CHAPTER _____

1 AN ACT concerning

2 **Hagerstown Community College Police Force – Jurisdiction**

3 FOR the purpose of authorizing a Hagerstown Community College police officer to exercise
4 powers granted to a peace and police officer ~~within Washington County~~ under certain
5 circumstances; and generally relating to the Hagerstown Community College Police
6 Force.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

1 **Article – Education**

2 16–407.1.

3 (a) There is a Hagerstown Community College Police Force.

4 (b) (1) A Hagerstown Community College police officer has the powers granted
5 to a peace and police officer.

6 (2) (i) **[A] EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
7 **PARAGRAPH, A** Hagerstown Community College police officer may exercise these powers
8 only on property that is owned, leased, operated by, or under the control of Hagerstown
9 Community College.

10 (ii) The police officer may [not] exercise these powers on any other
11 property [unless] ~~WITHIN WASHINGTON COUNTY IF:~~

12 1. Engaged in fresh pursuit of a suspected offender;

13 2. Necessary to facilitate the orderly flow of traffic to and
14 from property owned, leased, operated by, or under the control of Hagerstown Community
15 College; ~~or~~

16 3. Ordered to do so by the Governor; **OR**

17 **4. IN WASHINGTON COUNTY WHEN:**

18 **A. RESPONDING TO AN IMMINENT THREAT TO LIFE,**
19 **PROPERTY, OR PUBLIC SAFETY; OR**

20 **B. COMPLYING WITH A MEMORANDUM OF**
21 **UNDERSTANDING BETWEEN THE HAGERSTOWN COMMUNITY COLLEGE POLICE**
22 **FORCE AND ANOTHER LAW ENFORCEMENT AGENCY WITH JURISDICTION.**

23 (c) (1) In consultation with the Secretary of State Police and the Maryland
24 Police Training and Standards Commission, the Hagerstown Community College Board of
25 Trustees shall adopt standards, qualifications, and prerequisites of character, training,
26 education, human and public relations, and experience for Hagerstown Community College
27 police officers, including standards for the performance of their duties.

28 (2) To the extent practicable, the Board shall adopt standards that are
29 similar to the standards adopted for the Department of State Police.

1 (d) The Hagerstown Community College Board of Trustees shall adopt
2 regulations governing the operation and conduct of the Hagerstown Community College
3 Police Force and of Hagerstown Community College police officers.

4 (E) NOTHING IN THIS SECTION MAY BE CONSTRUED TO:

5 (1) SUPERSEDE THE AUTHORITY OR JURISDICTION OF:

6 (I) THE WASHINGTON COUNTY SHERRIFF’S OFFICE; OR

7 (II) ANY OTHER LAW ENFORCEMENT AGENCY, AS DEFINED IN §
8 1–101(C) OF THE PUBLIC SAFETY ARTICLE; OR

9 (2) LIMIT THE AUTHORITY OR JURISDICTION OF THE HAGERSTOWN
10 COMMUNITY COLLEGE POLICE FORCE AUTHORIZED UNDER § 5–802 OF THE
11 CRIMINAL LAW ARTICLE.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
13 1, 2025.
