

SECTION 2. AND BE IT FURTHER ENACTED, That § 11–405 of the Labor and Employment Article, as enacted by Section 1 of this Act, shall be construed to apply retroactively and shall be applied to and interpreted to affect only registered apprenticeship programs initially approved by the Maryland Apprenticeship and Training Council on or after January 1, 2023.
