- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 22 That the Laws of Maryland read as follows:

1 Article - Alcoholic Beverages and Cannabis

- This title applies only in Anne Arundel County.
- 4 11-903.
- 5 (a) There is a Class C beer, wine, and liquor license.
- 6 (b) The license authorizes the license holder to sell beer, wine, and liquor at retail, 7 at a club at the place described in the license, for on–premises consumption.
- 8 (c) The annual license fee is \$480.
- 9 11–1009.
- 10 (a) There is a Class C (veterans' organization) license.
- 11 (b) The Board shall issue the license for use by a local unit of a nationwide 12 nonprofit organization or club that:
- 13 (1) is composed only of members who served in the armed forces of the United States in a war in which the United States has been engaged;
- 15 (2) has a charter from a national veterans' organization that was granted 16 before the application for the license was made;
- 17 (3) has a bona fide membership of at least 100 individuals and dues of at least \$5 per year per individual; and
- 19 (4) operates for its members and meets in a clubhouse principally used for 20 its members.
- 21 (c) The license authorizes the license holder to sell beer, wine, and liquor at retail 22 at the place described in the license for on–premises consumption.
- 23 (d) The license holder may sell beer, wine, and liquor during the hours and days 24 as set out for a Class C [beer, wine, and liquor] (VETERANS' ORGANIZATION) license 25 under § 11–2004 of this title.
- (E) (1) A HOLDER OF A CLASS C BEER, WINE, AND LIQUOR LICENSE ISSUED UNDER § 11–903 OF THIS TITLE THAT QUALIFIES AS A VETERANS' ORGANIZATION UNDER SUBSECTION (B) OF THIS SECTION MAY APPLY TO CONVERT THE LICENSE TO A CLASS C (VETERANS' ORGANIZATION) LICENSE.

- 1 (2) THE CONVERSION TO AND ISSUANCE OF A CLASS C (VETERANS' 2 ORGANIZATION) LICENSE UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE 3 CONSIDERED A LICENSE RENEWAL AND NOT AN ISSUANCE OF A NEW LICENSE.
- 4 [(e)] (F) (1) The annual license fee is [\$400] \$300.
- 5 (2) THE BOARD MAY PROVIDE APPLICATION AND ADMINISTRATIVE 6 FEE DISCOUNTS TO AN ORGANIZATION THAT:
- 7 (I) QUALIFIES AS A VETERANS' ORGANIZATION UNDER 8 SUBSECTION (B) OF THIS SECTION; AND
- 9 (II) 1. HOLDS A CLASS C (VETERANS' ORGANIZATION) 10 LICENSE;
- 2. APPLIES FOR AN INITIAL OR RENEWAL CLASS C (VETERANS' ORGANIZATION) LICENSE; OR
- 3. HOLDS A CLASS C BEER, WINE, AND LIQUOR LICENSE
 THAT IS CONVERTED TO A CLASS C (VETERANS' ORGANIZATION) LICENSE UNDER
 SUBSECTION (E) OF THIS SECTION.
- 16 11–2004.
- 17 (c) (1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (4) OF THIS SUBSECTION, A holder of a Class C beer, wine, and liquor license may sell beer, wine, and liquor on Monday through Saturday from 6 a.m. to 2 a.m. the following day.
- 20 (2) Except as provided in [paragraph] PARAGRAPHS (3) AND (4) of this subsection, the license holder may not sell beer, wine, or liquor after 2 a.m. on Sunday.
- 22 (3) The Board may issue to the license holder a Sunday license that 23 authorizes the sale of beer, wine, and liquor on Sunday according to terms that the license 24 states.
- 25 (4) A HOLDER OF A CLASS C (VETERANS' ORGANIZATION) LICENSE 26 UNDER § 11–1009 OF THIS TITLE MAY SELL BEER, WINE, AND LIQUOR ON MONDAY 27 THROUGH SUNDAY FROM 6 A.M. TO 2 A.M. THE FOLLOWING DAY WITHOUT 28 OBTAINING A SUNDAY LICENSE UNDER PARAGRAPH (3) OF THIS SUBSECTION.
- 29 **[**(4)**] (5)** The license holder may sell or provide beer, wine, and liquor at a 30 bar or counter on any day on which the sale of beer, wine, and liquor is allowed by law.
