AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take effect on the taking effect of the termination provision specified in Section 4 of Chapters 484 and 485 of the Acts of the General Assembly of 2020. If the termination date of Chapters 484 or 485 is amended, Section 2 of this Act shall take effect on the termination of Chapters 484 or 485. This Act may not be interpreted to have any effect on that termination provision.

- 28 (3) the total amount of grant funds awarded to nonprofit organizations in 29 the State as a result of receiving technical assistance from the navigator in accordance with 30 Section 1 of this Act; and
- 31 (4) any findings and recommendations of the Department regarding the 32 implementation of Section 1 of this Act.

SECTION 6. AND BE IT FURTHER ENACTED, That, except as provided in Section 1 4 of this Act, this Act shall take effect July 1, 2025 is an emergency measure, is necessary 2 3 for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of 4 the General Assembly, and shall take effect from the date it is enacted. It shall remain 5 effective through June 30, 2027, and, at the end of June 30, 2027, this Act, with no further 6 action required by the General Assembly, shall be abrogated and of no further force and 7 8 effect.
