Public Health – Opioid Overdose Reversal Drugs

- FOR the purpose of requiring a licensed health care provider, when issuing a standing order for an opioid overdose reversal drug, to allow an individual to choose any formulation of any opioid overdose reversal drug approved by the federal Food and Drug Administration; prohibiting certain private and public entities that prescribe and dispense opioid overdose reversal drugs from being required to keep in stock or dispense all opioid overdose reversal drugs approved by the federal Food and Drug Administration; and generally relating to opioid overdose reversal drugs.

14AN AUTHORIZED PRIVATE OR PUBLIC ENTITY THAT PRESCRIBES AND15DISPENSES OPIOID OVERDOSE REVERSAL DRUGS MAY NOT BE REQUIRED TO KEEP16IN STOCK OR DISPENSE ALL OPIOID OVERDOSE REVERSAL DRUGS APPROVED BY THE17FEDERAL FOOD AND DRUG ADMINISTRATION.
