AN ACT concerning
Public Libraries – Automated External Defibrillator Program (Raymono A. Russell Act)
FOR the purpose of requiring operators of certain libraries, beginning on a certain date, to place an automated external defibrillator in a certain area, maintain the functionality of the automated external defibrillator, and ensure a trained individual is present under certain circumstances comply with the Public Access Automated External Defibrillator Program; granting certain immunities to libraries and individuals for certain acts or omissions under certain circumstances; altering the definition of "facility" for the purpose of excluding certain libraries from the Public Access Automated External Defibrillator Program; requiring the Maryland Department of Health and the Maryland Institute for Emergency Medical Services
