## A BILL ENTITLED

1 AN ACT concerning

2 **County Boards of Education – Student Cellular Phone Use Policy –**  
3 **Establishment**  
4 **(Maryland Phone–Free Schools Act)**

5 FOR the purpose of requiring each county board of education to develop and implement,  
6 not later than a certain school year, a policy limiting the use of a cellular phone by a  
7 student during the school day except under certain circumstances; and generally  
8 relating to county boards of education and a student cellular phone use policy.

9 BY adding to  
10 Article – Education  
11 Section 7–136  
12 Annotated Code of Maryland  
13 (2022 Replacement Volume and 2024 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 **7–136.**

18 **(A) IN THIS SECTION, “INSTRUCTIONAL TIME” MEANS ANY TIME DURING**  
19 **THE SCHOOL DAY, EXCEPT A STUDENT’S LUNCH PERIOD.**

20 **(B) NOT LATER THAN THE 2026–2027 SCHOOL YEAR, EACH COUNTY BOARD**  
21 **SHALL DEVELOP AND IMPLEMENT A POLICY TO LIMIT THE USE OF CELLULAR**  
22 **PHONES BY STUDENTS DURING INSTRUCTIONAL TIME.**

1 (C) EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, THE  
2 POLICY DEVELOPED UNDER THIS SECTION SHALL:

3 (1) PROHIBIT A STUDENT FROM USING A CELLULAR PHONE DURING  
4 INSTRUCTIONAL TIME;

5 (2) REQUIRE A STUDENT TO STORE THE STUDENT'S CELLULAR  
6 PHONE IN A SECURE PLACE DURING INSTRUCTIONAL TIME; AND

7 (3) PROHIBIT A STUDENT FROM USING THE SOCIAL MEDIA  
8 APPLICATIONS AND SOCIAL MEDIA WEBSITES DETERMINED BY THE COUNTY BOARD  
9 DURING SCHOOL HOURS.

10 (D) THE POLICY DEVELOPED UNDER THIS SECTION MAY NOT PROHIBIT A  
11 STUDENT FROM USING A CELLULAR PHONE:

12 (1) FOR ANY PURPOSE DOCUMENTED IN THE STUDENT'S  
13 INDIVIDUALIZED EDUCATION PROGRAM OR SECTION 504 PLAN;

14 (2) TO MONITOR OR ADDRESS A STUDENT'S DOCUMENTED HEALTH  
15 ISSUE;

16 (3) DURING AN EMERGENCY EVENT; OR

17 (4) WHEN DIRECTED BY AN EDUCATOR OR ADMINISTRATOR FOR  
18 EDUCATIONAL PURPOSES.

19 (E) (1) A POLICY DEVELOPED UNDER THIS SECTION SHALL INCLUDE  
20 APPROPRIATE DISCIPLINARY MEASURES FOR VIOLATIONS OF THE POLICY,  
21 INCLUDING A WARNING FOR AN INITIAL VIOLATION.

22 (2) THE DISCIPLINARY MEASURES ADOPTED UNDER PARAGRAPH (1)  
23 OF THIS SUBSECTION SHALL BE ENFORCED BY AN ADMINISTRATOR.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
25 1, 2025.
