FOR the purpose of increasing the number of commissioners appointed to the Public Service Commission; establishing certain residency requirements for each commissioner; altering the manner in which the Chair of the Commission is appointed; requiring

the Commission to submit, on or before a certain date, a slate of nominees to the

Governor for the initial appointment of certain commissioners; and generally relating to the Public Service Commission.

- 6 (a) With the advice and consent of the Senate, the Governor shall appoint a [Chairman] CHAIR FROM AMONG THE COMMISSIONERS.

- 9 (2) At the end of a term, the [Chairman] CHAIR continues to serve until a 10 successor qualifies.

- SECTION 2. AND BE IT FURTHER ENACTED, That, on or before August 1, 2025, the Public Service Commission shall submit a slate of nominees to the Governor for the initial appointment of the following two members added to the Public Service Commission as enacted under Section 1 of this Act:
- 17 (1) one member who is a resident of Western Maryland; and
- 18 (2) one member who is a resident of Southern Maryland.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to the term of the Chair or any other member of the Public Service Commission serving before the effective date of this Act.
- SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2025.
