- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

1 (b) If there is more than one appointed member of the Board whose length of 2 service would qualify that member for the termination of the member's term under 3 subsection (a) of this section, the members whose terms are subject to termination shall be 4 selected by randomized lottery from all those who qualify and the term of the member 5 selected in the lottery shall terminate on the date listed under subsection (a) of this section.
