## A BILL ENTITLED

## 2 Education - High School Graduation Requirements - Financial Aid Application

- 3 FOR the purpose of requiring each public high school student, beginning in a certain school
- 4 year, to complete and submit a certain financial aid form to the U.S. Department of
- 5 Education, the Maryland Higher Education Commission, or a county board of
- 6 education as a requirement for graduation; and generally relating to graduation
- 7 requirements for public high school students.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 19 That the Laws of Maryland read as follows:
- 20 Article Education
- 21 7–205.1.
- (b) (1) The State Board shall establish high school curriculum, college and
- 23 career readiness standards, and graduation requirements for all public schools in
- 24 accordance with this section.

- 1 (2) The State Board shall coordinate and consult with the Maryland Higher
- 2 Education Commission, the Governor's Workforce Development Board, the Maryland
- 3 Association of Community Colleges, and the Accountability and Implementation Board in
- 4 performing its duties under this subsection.
- 5 (M) (1) BEGINNING IN THE 2026–2027 SCHOOL YEAR, AND EXCEPT AS 6 PROVIDED IN PARAGRAPHS (2) AND (3) OF THIS SUBSECTION, EACH STUDENT, AS A
- 7 REQUIREMENT FOR GRADUATION, SHALL COMPLETE AND SUBMIT:
- 8 (I) THE FREE APPLICATION FOR FEDERAL STUDENT AID
- 9 (FAFSA) TO THE U.S. DEPARTMENT OF EDUCATION; OR
- 10 (II) THE MARYLAND STATE FINANCIAL AID APPLICATION
- 11 (MSFAA) TO THE MARYLAND HIGHER EDUCATION COMMISSION.
- 12 (2) A STUDENT OR THE PARENT OR LEGAL GUARDIAN OF A MINOR
- 13 STUDENT MAY SUBMIT TO THE COUNTY BOARD A FORM SIGNED BY THE STUDENT OR
- 14 THE PARENT OR LEGAL GUARDIAN OF THE MINOR STUDENT STATING THAT THE
- 15 STUDENT UNDERSTANDS THE FAFSA OR MSFAA AND DECLINES TO COMPLETE
- 16 AND SUBMIT THE FAFSA OR MSFAA.
- 17 (3) A COUNTY BOARD SHALL WAIVE THE REQUIREMENT IN
- 18 PARAGRAPH (1) OF THIS SUBSECTION IF:
- 19 (I) 1. A STUDENT COMPLETES ALL OTHER REQUIREMENTS
- 20 FOR GRADUATION IN THIS SECTION; AND
- 21 2. The student's principal attests that the
- 22 STUDENT HAS MADE A GOOD FAITH EFFORT TO COMPLETE THE FAFSA OR MSFAA;
- 23 **OR**
- 24 (II) A PARENT OR LEGAL GUARDIAN OF A STUDENT REQUESTS A
- 25 WAIVER DUE TO EXTENUATING CIRCUMSTANCES.
- 26 (4) (I) THE DEPARTMENT SHALL ADOPT REGULATIONS TO
- 27 IMPLEMENT THE REQUIREMENTS OF THIS SUBSECTION.
- 28 (II) THE REGULATIONS ADOPTED UNDER THIS PARAGRAPH
- 29 SHALL INCLUDE GUIDELINES TO ENSURE THAT EACH STUDENT RECEIVES
- 30 ADEQUATE SUPPORT IN COMPLETING AND SUBMITTING THE FAFSA OR MSFAA.
- 31 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before July 1 each year,
- 32 beginning in 2027 and ending in 2032, each county board shall report to the Senate
- 33 Committee on Education, Energy, and the Environment and the House Committee on Ways

- 1 and Means, in accordance with § 2–1257 of the State Government Article, on:
- 2 (1) the number of students who completed and submitted the Free
- 3 Application for Federal Student Aid (FAFSA) or the Maryland State Financial Aid
- 4 Application (MSFAA) in the immediately preceding school year;
- 5 (2) the number of students who declined to complete and submit the
- 6 FAFSA or the MSFAA in the immediately preceding school year; and
- 7 (3) the number of students who received a waiver under this Act in the
- 8 immediately preceding school year.
- 9 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 10 October 1, 2025.
