Natural Resources - State Boat Act - Alterations

3 FOR the purpose of altering the definition of "personal watercraft" and "personal flotation 4 device" for purposes of the State Boat Act; repealing the definition of "Class A vessel" 5 as it applies to the rental of livery vessels; repealing the definition of "personal 6 flotation device" as it applies to certain waterskiing restrictions; repealing certain 7 advertising and public hearing requirements for proposed regulations implementing 8 the State Boat Act; increasing the funding threshold for certain projects financed by 9 the Waterway Improvement Fund; altering the fees for manufacturer and dealer 10 licenses, certificates of number, Maryland use stickers, and the issuance of 11 certificates of title, transfer of title, or duplicate or corrected certificates of title; 12 authorizing the owner of certain vessels to apply to the Department of Natural 13 Resources for a nonmotorized vessel decal; authorizing the Department to establish 14 or alter certain speed zones or restricted areas by public notice; altering the 15 requirements for a personal flotation device worn by a child in certain vessels; and 16 generally relating to the State Boat Act.

- 1 (c) (1) Application for a manufacturer's or dealer's license is made on the form 2 the Department prescribes and contains the name and address of the applicant.

- 19 **(II)** The owner of the vessel may apply every other year for renewal 20 of the certificate.
- 21 (III) The renewed certificate shall expire on December 31 of the 22 calendar year following the year the certificate is issued. [The fee for a 2-year certificate 23 for vessels is \$24. Vessels 16 feet in length or less and equipped with a 7 1/2 horsepower 24 motor or less are exempt from this fee. The fee to replace a lost, destroyed, or corrected 25 certificate is \$2.1


