- 1 (a) Funds for the Grant shall be allocated by the Commission to an institution of 2 higher education based on the number of dually enrolled students receiving credit for 3 courses completed at the institution.
- 4 (b) Funds for the Grant shall be as provided in the annual budget of the 5 Commission by the Governor.
- 6 18–14A–03.
- 7 The Commission shall:
- 8 (1) Establish guidelines for awarding the Grant to dually enrolled 9 students; and
- 10 (2) Adopt any other guidelines or regulations necessary for the 11 administration of this subtitle.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 13 1, 2025.
