A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Reckless, Negligent, and Aggressive Driving**

3 FOR the purpose of altering the penalties and points assessments related to the offenses of
4 reckless, negligent, and aggressive driving; adding certain motor vehicle offenses as
5 elements that may contribute to charges for reckless or aggressive driving; and
6 generally relating to motor vehicle offenses.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That Section(s) 16–402(a)(17) of Article – Transportation of the Annotated Code of
5 Maryland be repealed.

6 SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 16–402(a)(13)
7 through (16) and (28) through (46) of Article – Transportation of the Annotated Code of
8 Maryland be renumbered to be Section(s) 16–402(a)(14) through (17) and (29) through (47),
9 respectively.

10 SECTION 3. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
11 as follows:

12 **Article – Transportation**

13 16–402.

14 (a) After the conviction of an individual for a violation of Title 2, Subtitle 5, §
15 2–209, § 3–211, or § 10–110 of the Criminal Law Article, or of the vehicle laws or regulations
16 of this State or of any local authority, points shall be assessed against the individual as of
17 the date of violation and as follows:

18 **(13) NEGLIGENCE DRIVING 2 POINTS**

19 **(28) SPEEDING IN EXCESS OF THE POSTED SPEED LIMIT BY 30 MILES**
20 **PER HOUR OR MORE 6 POINTS**

21 21–901.1.

22 (a) A person is guilty of reckless driving if [he] **THE PERSON** drives a motor
23 vehicle:

24 (1) In wanton or willful disregard for the safety of persons or property; [or]

25 (2) In a manner that indicates a wanton or willful disregard for the safety
26 of persons or property; **OR**

27 **(3) AT A SPEED AT LEAST 30 MILES PER HOUR ABOVE THE POSTED**
28 **SPEED LIMIT.**

29 (b) A person is guilty of negligent driving if [he] **THE PERSON** drives a motor
30 vehicle in a careless or imprudent manner that endangers any property or the life or person
31 of any individual.

1 (c) (1) A person convicted of a violation of subsection (a) of this section is
2 subject to **IMPRISONMENT NOT EXCEEDING 60 DAYS OR** a fine not exceeding \$1,000 **OR**
3 **BOTH.**

4 (2) **A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (B) OF**
5 **THIS SECTION IS SUBJECT TO A FINE NOT EXCEEDING \$750.**

7 (A) A person is guilty of aggressive driving if the person commits [three] **TWO** or
8 more of the following offenses at the same time or during a single and continuous period of
9 driving in violation of:

10 (1) **§ 21-201 OF THIS TITLE (FAILURE TO OBEY TRAFFIC CONTROL**
11 **DEVICE OR LEAVING ROADWAY TO AVOID TRAFFIC CONTROL DEVICE);**

12 (2) § 21-202 of this title (Traffic lights with steady indication);

13 [(2)] (3) § 21-303 of this title (Overtaking and passing vehicles);

14 [(3)] (4) § 21-304 of this title (Passing on right);

15 (5) **§ 21-305 OF THIS TITLE (DRIVING LEFT OF CENTER OF ROADWAY**
16 **IN OVERTAKING AND PASSING VEHICLE);**

17 (6) **§ 21-307 OF THIS TITLE (DRIVING ON LEFT IN NO-PASSING ZONE);**

18 [(4)] (7) § 21-309 of this title (Driving on laned roadways);

19 [(5)] (8) § 21-310 of this title (Following too closely);

20 [(6)] (9) § 21-403 of this title (Failure to yield right-of-way); [or]

21 (10) **§ 21-502(A)(2) OF THIS TITLE (FAILURE TO STOP FOR**
22 **PEDESTRIAN IN CROSSWALK);**

23 (11) **§ 21-502(C) OF THIS TITLE (OVERTAKING AND PASSING VEHICLE**
24 **STOPPED FOR PEDESTRIAN IN CROSSWALK);**

11 **BETWEEN LANES OF TRAFFIC OR VEHICLES).**

12 **(B) A PERSON CONVICTED OF A VIOLATION OF THIS SECTION IS SUBJECT TO**
13 **A FINE NOT EXCEEDING \$1,000.**

14 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2025.
