CHAPTER _____

1 AN ACT concerning

2 **Education – Sexual Abuse and Assault Awareness and Prevention Program –**
3 **Human and Sex Trafficking**

4 FOR the purpose of requiring that a certain program on the awareness and prevention of
5 sexual abuse and assault include, for students in certain grades, material promoting
6 the awareness and prevention of human and sex trafficking; and generally relating
7 to human and sex trafficking awareness and prevention programs in public and
8 nonpublic schools.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 7–439.

1 (a) In this section, “nonpublic school” means a noncollegiate educational
2 institution that:

3 (1) Holds a certificate of approval from the State Board under § 2–206(e) of
4 this article; and

5 (2) Participates in the Nonpublic Schools Textbook and Technology Grants
6 Program.

7 (b) (1) The State Board and each nonpublic school in the State shall develop
8 and implement a program of age–appropriate education on the awareness and prevention
9 of sexual abuse and assault.

10 (2) The program required under paragraph (1) of this subsection shall [be]:

11 (i) [Taught] **BE TAUGHT** by a teacher who is trained to provide
12 instruction on the awareness and prevention of sexual abuse and assault; [and]

13 (ii) [Incorporated] **BE INCORPORATED** into the health curriculum
14 of each county board and each nonpublic school; **AND**

15 **(III) INCLUDE, FOR STUDENTS IN GRADES 6 THROUGH 8,**
16 **MATERIAL PROMOTING THE AWARENESS AND PREVENTION OF HUMAN AND SEX**
17 **TRAFFICKING.**

18 (c) The State Board shall adopt regulations to carry out the provisions of this
19 section.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
21 1, 2025.
