14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

 2 interim report of its findings and recommendations to the Governor and, in accordance with
 3 § 2–1257 of the State Government Article, the General Assembly.

4 (2) On or before January 1, [2026] **2029**, the Commission shall submit a
 5 final report of its findings and recommendations to the Governor and, in accordance with §
 6 2–1257 of the State Government Article, the General Assembly.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
 8 1, 2024. It shall remain effective for a period of [2] **5** years and 1 month and, at the end of
 9 June 30, [2026] **2029**, this Act, with no further action required by the General Assembly,
 10 shall be abrogated and of no further force and effect.

11 **Chapter 946 of the Acts of 2024**

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 13 That:

14 (g) (1) On or before June 1, [2025] **2028**, the Commission shall submit an
 15 interim report of its findings and recommendations to the Governor and, in accordance with
 16 § 2–1257 of the State Government Article, the General Assembly.

17 (2) On or before January 1, [2026] **2029**, the Commission shall submit a
 18 final report of its findings and recommendations to the Governor and, in accordance with §
 19 2–1257 of the State Government Article, the General Assembly.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
 21 1, 2024. It shall remain effective for a period of [2] **5** years and 1 month and, at the end of
 22 June 30, [2026] **2029**, this Act, with no further action required by the General Assembly,
 23 shall be abrogated and of no further force and effect.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
 25 1, 2025.
