1 AN ACT concerning

Prince George's County – Natural Resources – Sunday Deer Hunting and Archery Hunting Safety Zones

- FOR the purpose of authorizing the Department of Natural Resources to allow a person to
 hunt deer on each Sunday of the deer bow hunting season in Prince George's County;
 adding Prince George's County to the list of counties in which the safety zone for
 archery hunters extends a certain distance from certain structures; and generally
 relating to hunting in Prince George's County.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 2 1, 2025.
