A BILL ENTITLED

1 AN ACT concerning

2 **Queen Anne's County – Circuit Court Judgeships**

3 FOR the purpose of increasing the number of resident judges of the Circuit Court for Queen
4 Anne's County; and generally relating to circuit court judgeships in Queen Anne's

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Courts and Judicial Proceedings**

19 1–501.

20 The circuit courts are the highest common-law and equity courts of record exercising
21 original jurisdiction within the State. Each has full common-law and equity powers and
22 jurisdiction in all civil and criminal cases within its county, and all the additional powers
23 and jurisdiction conferred by the Constitution and by law, except where by law jurisdiction
24 has been limited or conferred exclusively upon another tribunal.
