AND BE IT FURTHER ENACTED, That the certification agency designated by the Board of Public Works under § 14-303(b) of the State Finance and Procurement Article to certify and decertify minority business enterprises, in consultation with the Office of the Attorney General and the Governor's Office of Small, Minority, and Women Business Affairs, shall initiate an analysis of the Minority Business Enterprise Program requirements of § 10A-404 of the State Finance and Procurement Article and the disparity study submitted in accordance with this Act to evaluate compliance with the requirements of any federal and constitutional requirements and submit a report on the analysis to the Legislative Policy Committee of the General Assembly, in accordance with § 2–1257 of the State Government Article, on or before September 30, [2024] 2025.

SECTION 5. AND BE IT FURTHER ENACTED, That the certification agency designated by the Board of Public Works under § 14–303(b) of the State Finance and Procurement Article to certify and decertify minority business enterprises, in consultation with the Office of the Attorney General and the Governor's Office of Small, Minority, and Women Business Affairs, shall initiate an analysis of the disparity study submitted in accordance with this Act to determine if it applies to the type of work that will be likely to be performed by an approved applicant with respect to an offshore wind project under § 7–704.1(i) of the Public Utilities Article as enacted by Section 2 of this Act and submit a report on the analysis to the Legislative Policy Committee of the General Assembly, in accordance with § 2–1257 of the State Government Article, on or before September 30, [2024] 2025.

SECTION 2. AND BE IT FURTHER ENACTED, That the Certification Agency, in consultation with the General Assembly and the Office of the Attorney General, shall initiate a study of the Minority Business Enterprise Program to evaluate the Program's continued compliance with the requirements of the Croson decision and any subsequent federal or constitutional requirements. In preparation for the study, the Board of Public Works may adopt regulations authorizing a unit of State government to require bidders and offerors to submit information necessary for the conduct of the study. The Board of Public Works may designate that certain information received in accordance with regulations adopted under this section shall be confidential. Notwithstanding that certain information may be designated by the Board of Public Works as confidential, the Certification Agency may provide the information to any person that is under contract with the Certification Agency to assist in conducting the study. The study shall also evaluate race—neutral programs and other methods that can be used to address the needs of minority businesses. The final report on the study shall be submitted to the Legislative Policy Committee of the General Assembly, in accordance with § 2–1257 of the State Government Article, on or before September 30, [2024] 2025, so that the General Assembly may review the report before the [2025] **2026** Session.

SECTION 2. AND BE IT FURTHER ENACTED, That:

- (b) The certification agency and the Governor's Office of Small, Minority, and 32Women Business Affairs shall submit the findings of the study required under subsection 33 (a) of this section to the Legislative Policy Committee, in accordance with § 2–1257 of the 34 State Government Article, on or before December 31, [2025] 2026, so that the General 35 Assembly may review the findings before the [2026] **2027** Session.
- 36 The Governor's Office of Small, Minority, and Women Business Affairs, in 37 consultation with the certification agency and the Office of the Attorney General, shall 38 develop race- and gender-neutral approaches to address the needs of minority and

women—owned businesses in the brokerage and investment management services industry and market and submit its report to the Legislative Policy Committee, in accordance with § 2–1257 of the State Government Article, on or before December 31, [2025] **2026**, so that the General Assembly may review, consider, and adopt race— and gender—neutral alternatives to remedial measures that are not race and gender neutral.
