## A BILL ENTITLED

1 AN ACT concerning

2 **Education – Public Middle Schools – Course on Consequences of a Felony**  
3 **Murder Conviction**

4 FOR the purpose of requiring the State Board of Education to develop curriculum standards  
5 and county boards of education to develop and implement a curriculum for a course  
6 on the consequences of a conviction for felony murder for public middle school  
7 students in the State; and generally relating to a course on the consequences of a  
8 conviction for felony murder curriculum requirement for public middle school  
9 students.

13 Annotated Code of Maryland

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Education**

18 **7–213.**

19 **(A) IN THIS SECTION, “CONSEQUENCES OF A CONVICTION FOR FELONY**  
20 **MURDER” MEANS THE LEGAL PENALTIES THAT TAKE AWAY AN INDIVIDUAL’S**  
21 **FREEDOM, RIGHTS, AND ACCESS TO PROGRAMS OR SERVICES AFTER CONVICTION**  
22 **FOR MURDER IN THE FIRST DEGREE UNDER § 2–201(A)(4) OF THE CRIMINAL LAW**  
23 **ARTICLE.**

24 **(B) THE STATE BOARD SHALL DEVELOP AGE-APPROPRIATE CURRICULUM**

1 STANDARDS FOR A COURSE ON THE CONSEQUENCES OF A CONVICTION FOR FELONY  
2 MURDER FOR STUDENTS IN GRADES 6 THROUGH 8 IN PUBLIC SCHOOLS IN THE  
3 STATE.

4 (C) (1) BEGINNING IN THE 2026–2027 SCHOOL YEAR, EACH COUNTY  
5 BOARD SHALL DEVELOP AND IMPLEMENT A CURRICULUM BASED ON THE  
6 CONSEQUENCES OF A CONVICTION FOR FELONY MURDER CURRICULUM STANDARDS  
7 DEVELOPED BY THE STATE BOARD UNDER SUBSECTION (B) OF THIS SECTION.

8 (2) EACH COUNTY BOARD SHALL ENSURE THAT A COURSE ON THE  
9 CONSEQUENCES OF A CONVICTION FOR FELONY MURDER IS TAUGHT TO STUDENTS  
10 AT LEAST ONCE DURING GRADES 6 THROUGH 8.

11 (D) THE STATE BOARD MAY ADOPT REGULATIONS TO CARRY OUT THIS  
12 SECTION.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
14 1, 2025.
