FOR the purpose of establishing the Workgroup to Study Implementation of a Statewide an Expanded 3-1-1 Nonemergency Telephone System; and generally relating to the Workgroup to Study Implementation of a Statewide an Expanded 3-1-1 Nonemergency Telephone System.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 9 That:
