A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County Planning Board and Washington Suburban Sanitary**
3 **Commission – Open Meetings – Live Streaming Requirement**

4 **MC/PG 101–25**

5 FOR the purpose of altering the requirement that the Montgomery County Planning Board
6 and the Washington Suburban Sanitary Commission, respectively, stream live video
7 or audio of their open meetings to apply only to meetings held at certain locations;
8 and generally relating to open meetings of the Montgomery County Planning Board
9 and the Washington Suburban Sanitary Commission.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Land Use**

1 (e) (1) This subsection applies only to the Montgomery County Planning
2 Board.

3 (2) The Board shall:

4 (i) stream live video or live teleconference audio or other audio of
5 the open meetings of the Board **ONLY IF THE MEETING IS HELD AT:**

6 **1. THE HEADQUARTERS OF THE BOARD; OR**

7 **2. A LOCATION WHERE THE BOARD HELD AT LEAST 10**
8 **MEETINGS DURING THE IMMEDIATELY PRECEDING CALENDAR YEAR;**

9 (ii) maintain on its website a complete and unedited archived
10 recording of each open meeting that is livestreamed in accordance with this subsection; and

11 (iii) notwithstanding § 3–306(b)(2)(i) of the General Provisions
12 Article:

13 1. prepare minutes of each meeting as soon as practicable
14 after the meeting; and

15 2. publish and maintain on its website the minutes of each
16 open meeting prepared in accordance with this subsection.

17 (3) The inability of the Board to comply with paragraph (2)(i) and (ii) of this
18 subsection due to technical failure that entirely prevents or otherwise affects the quality of
19 the live video or audio streaming of a meeting of the Board does not affect the validity of
20 any action taken by the Board during the meeting if:

21 (i) the Board otherwise complies with this subsection and the Open
22 Meetings Act; and

23 (ii) the inability to comply is not due to willful action by the Board.

24 (4) In addition to complying with the minutes requirements of the Open
25 Meetings Act under § 3–306 of the General Provisions Article, if the Board is unable to
26 comply with paragraph (2)(i) of this subsection, the Board shall make good-faith efforts to
27 record an open meeting by video or audio and maintain on its website a complete and
28 unedited archived recording of the meeting.

31 (e) (1) The Commission shall:

1 (i) stream live video or live teleconference audio or other audio of
2 the open meetings of the Commission **ONLY IF THE MEETING IS HELD AT:**

3 **1. THE HEADQUARTERS OF THE COMMISSION; OR**

4 **2. A LOCATION WHERE THE COMMISSION HELD AT**
5 **LEAST 10 MEETINGS DURING THE IMMEDIATELY PRECEDING CALENDAR YEAR; and**

6 (ii) maintain on its website a complete and unedited archived
7 recording of each open meeting that is livestreamed in accordance with this subsection.

8 (2) The inability of the Commission to comply with paragraph (1) of this
9 subsection due to technical failure that entirely prevents or otherwise affects the quality of
10 the live video or audio streaming of a meeting of the Commission does not affect the validity
11 of any action taken by the Commission during the meeting if:

12 (i) the Commission otherwise complies with this section and the
13 Open Meetings Act; and

14 (ii) the inability to comply is not due to willful action by the
15 Commission.

16 (3) In addition to complying with the minutes requirements of the Open
17 Meetings Act under § 3–306 of the General Provisions Article, if the Commission is unable
18 to comply with the requirements of paragraph (1)(i) of this subsection, the Commission
19 shall make good faith efforts to record an open session by video or audio and maintain on
20 its website a complete and unedited archived recording of the meeting.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2025.
