14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

18 19	(A) ON OR BEFORE JULY 1, 2026, EACH COUNTY BOARD SHALL DEVELOP INSTRUCTIONAL CONTENT ON WATER SAFETY AND SWIMMING THAT IS:

INTEGRATED INTO THE HEALTH AND PHYSICAL EDUCATION

CURRICULUM FOR EACH PUBLIC SCHOOL IN THE COUNTY; AND

- 1 (2) AGE-APPROPRIATE FOR STUDENTS IN ELEMENTARY, MIDDLE, 2 AND HIGH SCHOOL.
- 3 (B) THE INSTRUCTIONAL CONTENT DEVELOPED UNDER SUBSECTION (A) OF 4 THIS SECTION SHALL INCLUDE OPPORTUNITIES FOR STUDENTS WITH DISABILITIES, 5 IF PRACTICABLE.
- 6 (C) BEGINNING IN THE 2026–2027 SCHOOL YEAR, EACH COUNTY BOARD 7 SHALL IMPLEMENT THE INSTRUCTIONAL CONTENT DEVELOPED UNDER 8 SUBSECTION (A) OF THIS SECTION.

9 SECTION 2. AND BE IT FURTHER ENACTED, That:

- 10 (a) (1) On or before December 1, 2025, each county board of education shall develop a plan to ensure public school students in the county have access to swimming pools for swimming and taking swimming and water safety courses.
- 13 (2) The plan required under this subsection shall:
- 14 (i) identify strategies to maximize public and private resources to 15 provide access to swimming pools and related facilities for public school students;
- 16 (ii) identify public and private entities in the local community that 17 could partner with schools to offer access to swimming pools and related facilities to public 18 school students during school operating hours;
- 19 (iii) identify methods to increase public school student access to swimming pools and related facilities, including costs and transportation, while keeping costs low; and
- 22 (iv) recommend any necessary changes to policy or law to implement 23 the plan required under paragraph (1) of this subsection and the requirements of § 7–452 24 of the Education Article, as enacted by Section 1 of this Act.
- 25 (b) On or before December 15, 2025, each county board shall submit a copy of the 26 plan developed under subsection (a) of this section to the State Department of Education.
- 27 (c) On or before January 1, 2026, the State Department of Education shall 28 compile the reports submitted under subsection (b) of this section and submit a report that 29 includes all the county boards' plans to the General Assembly, in accordance with § 30 2–1257 of the State Government Article.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2025. Section 2 of this Act shall remain effective for a period of 1 year and, at the end of June 30, 2026, Section 2 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
