## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Transit Administration – Baltimore East–West Corridor – Property**  
3 **Acquisition**

4 FOR the purpose of prohibiting the Maryland Transit Administration, in conducting the  
5 Red Line transit project, from acquiring any real property for planning, construction,  
6 operation, or maintenance of the Red Line if the acquisition would result in  
7 involuntary residential displacement; and generally relating to the Maryland  
8 Transit Administration and the Baltimore metropolitan area east–west corridor.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

15 That the Laws of Maryland read as follows:

16 **Article – Transportation**

17 **7–718.**

18 **(A) IN THIS SECTION, “RED LINE” MEANS A RAIL TRANSIT FACILITY USING**  
19 **ONE OR MORE VEHICLES OPERATING IN TANDEM ON A FIXED RAIL IN A**  
20 **COMBINATION OF AT–GRADE, ELEVATED, AND UNDERGROUND CONFIGURATIONS**  
21 **THROUGH BALTIMORE CITY AND BALTIMORE COUNTY ALONG A GENERALLY**  
22 **EAST–TO–WEST ALIGNMENT BETWEEN THE TERMINUS OF SECURITY BOULEVARD**  
23 **ON THE WEST AND THE JOHNS HOPKINS BAYVIEW MEDICAL CENTER ON THE EAST,**  
24 **CONNECTING AS APPROPRIATE TO OTHER FIXED–ROUTE TRANSIT SERVICES.**

1           **(B) IN CONDUCTING THE RED LINE TRANSIT PROJECT, THE**  
2 **ADMINISTRATION MAY NOT ACQUIRE ANY REAL PROPERTY FOR PLANNING,**  
3 **CONSTRUCTION, OPERATION, OR MAINTENANCE OF THE RED LINE IF THE**  
4 **ACQUISITION WOULD RESULT IN INVOLUNTARY RESIDENTIAL DISPLACEMENT.**

5           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
6 1, 2025.
