BY repealing and reenacting, without amendments, Article – Education Section 10-101(a) and (j) Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) BY adding to Article – Education Section 11–212 Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
