- 1 (2) NOTHING IN THIS SECTION MAY BE CONSTRUED TO LIMIT OR 2 PROHIBIT THE ENFORCEMENT OF ANY OTHER STATE LAW.
- 3 (E) THE SECRETARY SHALL ADOPT REGULATIONS TO CARRY OUT THIS 4 SECTION.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 October 1, 2025.
