2 Heating, Ventilation, Air-Conditioning, or Refrigeration Contractors – 3 Equipment Sales

- 4 FOR the purpose of prohibiting a person from knowingly offering to sell or selling heating, 5 ventilation, air-conditioning, or refrigeration equipment to an individual that is does 6 not licensed hold a certain license issued by the Board of Heating, Ventilation, 7 Air-Conditioning, or Refrigeration Contractors except under certain circumstances; 8 requiring certain persons to collect certain information from or provide a certain 9 notice to purchasers of heating, ventilation, air-conditioning, or refrigeration 10 equipment at the time of sale; requiring certain sellers of heating, ventilation, 11 air-conditioning, or refrigeration equipment to submit a certain report to the Board 12 each fiscal year; and generally relating to heating, ventilation, air-conditioning, or 13 refrigeration contractors.
