4	FOR the purpose of prohibiting a county or municipality from enacting or enforcing a local
5	law that is designed to prevent an individual from resting or sleeping in a public
6	space, protecting oneself from the elements in a manner that does not obstruct the
7 8	use of or access to private property, or sleeping in a legally parked vehicle; and generally relating to local laws regarding homeless individuals.

14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND
15	That the Laws of Maryland read as follows:
16	Article – Local Government
17	1–1321.
18	(A) THE GENERAL ASSEMBLY FINDS AND DECLARES THAT:
19	(1) MANY INDIVIDUALS EXPERIENCE HOMELESSNESS BECAUSE OF
20	ECONOMIC HARDSHIP, A SEVERE SHORTAGE OF SAFE AND AFFORDABLE HOUSING
21	THE INABILITY TO SECURE GAINFUL EMPLOYMENT, AND DISINTEGRATING AND
22	SHRINKING SOCIAL SAFETY NETS;

1	(2) RESPONDING TO THE GROWING CRISIS OF HOMELESSNESS WITH
2	CRIMINAL SANCTIONS TO PUSH INDIVIDUALS OUT OF PUBLIC SPACES AND INTO
3	COURTS AND JAILS IS COSTLY, INHUMANE, AND INEFFECTIVE AND VIOLATES BASIC
4	CIVIL, HUMAN, AND CONSTITUTIONAL RIGHTS;
5	(3) THE EXISTENCE OF HOMELESSNESS REQUIRES THAT CIVIL AND
6	HUMAN RIGHTS THAT ARE AMPLY PROTECTED IN THE HOME AND IN OTHER PRIVATE
7	PLACES BE EXTENDED TO THE PUBLIC SPACES IN WHICH INDIVIDUALS
8	EXPERIENCING HOMELESSNESS LIVE TO ENSURE THE EQUAL RIGHTS OF ALL
9	CITIZENS OF THE STATE;
10	(4) COUNTIES AND MUNICIPALITIES THROUGHOUT THE UNITED
11	STATES ARE ENACTING AND ENFORCING LOCAL LAWS THAT CRIMINALIZE BASIC
12	ACTS OF SURVIVAL, INCLUDING:
13	(I) SLEEPING, SITTING, OR LOITERING IN A PUBLIC SPACE;

- 14 (II) SLEEPING IN A LEGALLY PARKED VEHICLE;
- 15 (III) HAVING A REASONABLE EXPECTATION OF PRIVACY FOR
- 16 PERSONAL PROPERTY;
- 17 (IV) STORING BELONGINGS;
- 18 (V) ASKING FOR HELP; AND
- 19 (VI) USING A BLANKET TO COVER ONESELF IN A 20 NONOBSTRUCTIVE MANNER REGARDLESS OF OUTDOOR TEMPERATURE;
- 21 (5) THESE LOCAL LAWS:
- 22 (I) RESULT IN INDIVIDUALS BEING CRIMINALLY PUNISHED FOR 23 DOING WHAT ANY INDIVIDUAL MUST DO TO SURVIVE;
- 24 (II) DO NOT REDUCE THE INCIDENCE OF HOMELESSNESS OR
- 25 CRIME, BUT RATHER INCREASE INCARCERATION RATES AND FINANCIAL
- 26 INDEBTEDNESS OF INDIVIDUALS WHO SIMPLY HAVE NO MEANS OF SUPPORTING
- 27 THEMSELVES; AND
- 28 (III) PROLONG HOMELESSNESS BY MAKING IT MORE DIFFICULT
- 29 FOR INDIVIDUALS TO SECURE HOUSING, EMPLOYMENT, AND MEDICAL CARE;

1	(6) WHILE THESE LOCAL LAWS APPLY TO ALL RESIDENTS IN THE
2	LOCAL JURISDICTION, THE LAWS:
3	(I) DISPROPORTIONATELY IMPACT INDIVIDUALS
4	EXPERIENCING HOMELESSNESS; AND
5	(II) ARE OFTEN SELECTIVELY ENFORCED AGAINST PEOPLE
6	BASED ON THEIR APPEARANCE OR AN ASSUMPTION OF HOMELESSNESS; AND
7	(7) PROHIBITING LOCAL JURISDICTIONS IN THE STATE FROM
8	PASSING OR ENFORCING LOCAL LAWS THAT DISPROPORTIONATELY IMPACT OR ARE
9	INTENDED TO IMPACT INDIVIDUALS EXPERIENCING HOMELESSNESS WILL PERMIT
10	THE LOCAL JURISDICTIONS TO REDIRECT RESOURCES AND SHIFT THE FOCUS FROM
11	LAW ENFORCEMENT TO POSITIVE APPROACHES THAT DIRECTLY ADDRESS
12	HOMELESSNESS AND POVERTY.
13	(B) A COUNTY OR MUNICIPALITY MAY NOT ENACT OR ENFORCE A LOCAL
14	LAW THAT IS DESIGNED TO PREVENT AN INDIVIDUAL FROM:

- 15 (1) RESTING OR SLEEPING IN A PUBLIC SPACE;
- 16 (2) PROTECTING ONESELF FROM THE ELEMENTS IN A MANNER THAT 17 DOES NOT OBSTRUCT THE USE OF OR ACCESS TO PRIVATE PROPERTY; OR
- 18 (3) SLEEPING IN A LEGALLY PARKED VEHICLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 20 October 1, 2025.
