A BILL ENTITLED

1 AN ACT concerning

2 **Health Insurance – Scalp Cooling Systems – Required Coverage**

3 FOR the purpose of requiring certain insurers, nonprofit health service plans, health
4 maintenance organizations, and managed care organizations that provide coverage
5 for chemotherapy to treat cancer to provide coverage for scalp cooling systems; and
6 generally relating to the coverage of scalp cooling systems by health insurance
7 carriers.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Insurance**

16 **15–861.**

17 **(A) THIS SECTION APPLIES TO:**

18 **(1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT**
19 **PROVIDE HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS**
20 **ON AN EXPENSE–INCURRED BASIS UNDER HEALTH INSURANCE POLICIES OR**
21 **CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE; AND**

22 **(2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE**

1 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS UNDER
2 CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE.

3 (B) AN ENTITY SUBJECT TO THIS SECTION THAT PROVIDES COVERAGE FOR
4 CHEMOTHERAPY TO TREAT CANCER SHALL PROVIDE COVERAGE FOR SCALP
5 COOLING SYSTEMS USED FOR THE PRESERVATION OF HAIR IN CONNECTION WITH
6 THE CHEMOTHERAPY TREATMENT.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all
8 policies, contracts, and health benefit plans issued, delivered, or renewed in the State on or
9 after January 1, 2026.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 January 1, 2026.
