12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 3–902.

16 (a) An elected member of the county board is entitled to reimbursement for travel
17 and other expenses as provided by the Montgomery County Council.

18 (b) (1) An elected member of the county board is entitled to receive~~f~~:

 22 SUBSECTION SHALL TAKE EFFECT AT THE BEGINNING OF THE TERM OF OFFICE AND
 23 MAY NOT INCREASE DURING THE TERM OF OFFICE.

27 (2) ~~[(i)] A student member who completes a full term on the county board~~
 28 ~~shall [be granted a scholarship to be applied toward the student's higher education costs.~~

~~(ii) 1. Except as provided in subsubparagraph 2 of this subparagraph, the scholarship amount is equal to the highest annual resident undergraduate tuition, mandatory fees, and room and board that is charged at a 4-year public institution of higher education within the University System of Maryland, other than the University of Maryland Global Campus and University of Maryland, Baltimore Campus, for the academic year in which the student member serves on the county board;~~

(I) MAY BE REIMBURSED FOR OUT-OF-POCKET EXPENSES INCURRED IN CONNECTION WITH OFFICIAL DUTIES; AND

(II) SHALL BE GRANTED COMPENSATION IN ACCORDANCE WITH PARAGRAPH (2) OF THIS SUBSECTION.

(2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE COMPENSATION AMOUNT OF THE STUDENT MEMBER IS EQUAL TO THE HIGHEST ANNUAL RESIDENT UNDERGRADUATE TUITION, MANDATORY FEES, AND ROOM AND BOARD THAT IS CHARGED AT A 4-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION WITHIN THE UNIVERSITY SYSTEM OF MARYLAND, OTHER THAN THE UNIVERSITY OF MARYLAND GLOBAL CAMPUS AND UNIVERSITY OF MARYLAND, BALTIMORE CAMPUS, FOR THE ACADEMIC YEAR IN WHICH THE STUDENT MEMBER SERVES ON THE COUNTY BOARD.

(II) 1. SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS SUBPARAGRAPH, THE STUDENT MEMBER MAY ELECT TO RECEIVE COMPENSATION GRANTED UNDER THIS SUBSECTION IN MONTHLY INSTALLMENTS AS A STIPEND DURING THE STUDENT MEMBER'S TERM AND RECEIVE ANY REMAINING AMOUNT AS A SCHOLARSHIP AFTER THE END OF THE TERM.

2. The amount of a ~~scholarship~~ COMPENSATION granted under this subsection in any year may not exceed the amount that an elected member of the county board is entitled to receive under subsection (b) of this section in that year.~~]~~
~~RECEIVE AS FOLLOWS:~~

~~(i) THROUGH THE TERM THAT ENDS IN 2026, A SCHOLARSHIP EQUAL TO 40% OF THE ANNUAL COMPENSATION OF AN ELECTED MEMBER OF THE COUNTY BOARD FOR THAT YEAR TO BE APPLIED TOWARD THE STUDENT'S HIGHER EDUCATION COSTS AND A ONE-TIME STIPEND EQUAL TO 10% OF THE ANNUAL COMPENSATION OF AN ELECTED MEMBER OF THE COUNTY BOARD; AND~~

~~(ii) BEGINNING WITH THE TERM THAT STARTS IN 2026, A SCHOLARSHIP EQUAL TO 80% OF THE ANNUAL COMPENSATION OF AN ELECTED MEMBER OF THE COUNTY BOARD FOR THAT YEAR TO BE APPLIED TOWARD THE STUDENT'S HIGHER EDUCATION COSTS AND A ONE-TIME STIPEND EQUAL TO 20% OF THE ANNUAL COMPENSATION OF AN ELECTED MEMBER OF THE COUNTY BOARD.~~

1 ~~SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with Article~~
2 ~~III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to~~
3 ~~the salary or compensation of the president and members of the Montgomery County Board~~
4 ~~of Education while serving in a term of office beginning before the effective date of this Act,~~
5 ~~but the provisions of this Act concerning the salary or compensation of the president and~~
6 ~~members of the Montgomery County Board of Education shall take effect at the beginning~~
7 ~~of the next following term of office. This limitation does not apply to an individual appointed~~
8 ~~or elected after the effective date of this Act to fill out an unexpired term.~~

10 July 1, 2025.
