9 ~~authorizing the Board to consider certain public testimony~~ consider, before deciding
10 whether to approve an application and issue a new license permitting the sale of
11 alcoholic beverages for off-premises consumption, the impact of the density of
12 existing retail establishments licensed in the county to sell alcoholic beverages for
13 off-premises consumption on the public health and safety of the community; and

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Alcoholic Beverages and Cannabis**

17 (a) Before deciding whether to approve an application and issue a license, a local
18 licensing board shall consider:

19 (1) the public need and desire for the license;

20 (2) the number and location of existing license holders;

21 (3) the potential effect on existing license holders of the license for which
22 application is made;

23 (4) the potential commonality or uniqueness of the services and products
24 to be offered by the business of the applicant;

25 (5) the impact of the license for which application is made on the health,
26 safety, and welfare of the community, including issues relating to crime, traffic, parking,
27 or convenience; and

28 (6) any other factor that the local licensing board considers necessary.

19 (a) The following sections of Title 4, Subtitle 2 (“Issuance or Denial of Local
 20 Licenses”) of Division I of this article apply in the county without exception or variation:

21 (1) § 4-205 (“Chain store, supermarket, or discount house”);

22 (2) § 4-206 (“Limitations on retail sales floor space”);

23 (3) § 4-207 (“Licenses issued to minors”);

24 (4) § 4-209 (“Hearing”);

25 (5) [§ 4-210 (“Approval or denial of license application”);

26 (6)] § 4-211 (“License forms; effective date; expiration”);

27 [(7)] (6) § 4-212 (“License not property”); and

28 [(8)] (7) § 4-213 (“Replacement licenses”).

1 (b) Section 4–214 (“Waiting periods after denial of license applications”) of
2 Division I of this article does not apply in the county.

3 (c) The following sections of Title 4, Subtitle 2 (“Issuance or Denial of Local
4 Licenses”) of Division I of this article apply in the county:

5 (1) § 4–202 (“Authority of local licensing boards”), subject to § 25–1502 of
6 this subtitle;

7 (2) § 4–203 (“Prohibition against issuing multiple licenses to individual or
8 for use of entity”), subject to § 25–1503 of this subtitle and Subtitle 13, Part III and Subtitle
9 16, Part II of this title;

10 (3) § 4–204 (“Prohibition against issuing multiple licenses for same
11 premises”), subject to § 25–1503 of this subtitle and Subtitle 13, Part III of this title; [and]

12 (4) § 4–208 (“Notice of license application required”), subject to § 25–1506
13 of this subtitle; AND

14 (5) § 4–210 (“APPROVAL OR DENIAL OF LICENSE APPLICATION”),
15 SUBJECT TO ~~§ 25–207~~ § 25–1507 OF THIS SUBTITLE.

17 BEFORE DECIDING WHETHER TO APPROVE AN APPLICATION AND ISSUE A NEW
18 LICENSE PERMITTING THE SALE OF ALCOHOLIC BEVERAGES FOR OFF-PREMISES
19 CONSUMPTION, THE BOARD SHALL CONSIDER THE IMPACT OF THE DENSITY OF
20 EXISTING RETAIL ESTABLISHMENTS LICENSED IN THE COUNTY TO SELL ALCOHOLIC
21 BEVERAGES FOR OFF-PREMISES CONSUMPTION ON THE PUBLIC HEALTH AND
22 SAFETY OF THE COMMUNITY.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2025.
