1 AN ACT concerning

2 **Somerset County – Alcoholic Beverages – Liquor Tasting License**

3 FOR the purpose of establishing a liquor tasting license in Somerset County; authorizing
4 the Board of License Commissioners for Somerset County to issue the license to the
5 holder of a Class A beer, wine, and liquor license; and generally relating to alcoholic
6 beverages in Somerset County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages and Cannabis**

20 29–102.

3 (A) **THERE IS A LIQUOR TASTING LICENSE.**

4 (B) **THE BOARD MAY ISSUE THE LICENSE TO A HOLDER OF A CLASS A BEER,**
5 **WINE, AND LIQUOR LICENSE.**

6 (C) **THE LICENSE AUTHORIZES THE HOLDER TO ALLOW THE CONSUMPTION**
7 **OF LIQUOR FOR TASTING IF:**

8 (1) **THE LICENSE HOLDER IS AUTHORIZED TO SELL THE LIQUOR; AND**

9 (2) **THE CONSUMER IS NOT CHARGED FOR THE LIQUOR.**

10 (D) **AN INDIVIDUAL MAY CONSUME LIQUOR AT A LIQUOR TASTING IN A**
11 **QUANTITY OF NOT MORE THAN:**

12 (1) **ONE-HALF OUNCE FROM EACH OFFERING OF LIQUOR; AND**

13 (2) **FIVE OFFERINGS IN 1 DAY.**

14 (E) **IN ADDITION TO THE COST OF THE CLASS A BEER, WINE, AND LIQUOR**
15 **LICENSE, THE LIQUOR TASTING LICENSE FEES ARE:**

16 (1) **FOR A LICENSE THAT IS EFFECTIVE FOR ONLY 1 DAY IN A**
17 **LICENSING PERIOD, \$20;**

18 (2) **FOR A LICENSE THAT IS EFFECTIVE FOR ANY 26 DAYS IN A**
19 **LICENSING PERIOD, \$200;**

20 (3) **FOR A LICENSE THAT IS EFFECTIVE FOR ANY 52 DAYS IN A**
21 **LICENSING PERIOD, \$300; AND**

22 (4) **FOR A LICENSE THAT IS EFFECTIVE FOR ANY 104 DAYS IN A**
23 **LICENSING PERIOD, \$400.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2025.
