A BILL ENTITLED

1 AN ACT concerning

2 **Charles County – Off-Highway Recreational Vehicles – Regulation and**
3 **Enforcement**

4 FOR the purpose of authorizing Charles County to regulate the operation of off-highway
5 recreational vehicles in the county and to impound an off-highway recreational
6 vehicle that is the subject of certain alleged motor vehicle violations; and generally
7 relating to off-highway recreational vehicles in Charles County.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Transportation**

16 25–102.

17 (a) The provisions of the Maryland Vehicle Law do not prevent a local authority,
18 in the reasonable exercise of its police power, from exercising the following powers as to
19 highways under its jurisdiction:

20 (1) Subject to the provisions of § 21–1003.1 of this article, regulating or
21 prohibiting the stopping, standing, or parking of vehicles;

22 (2) Regulating traffic by means of police officers or traffic control devices;

23 (3) Regulating or prohibiting processions or assemblies on highways;

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



- 1 (4) Designating particular highways or separate roadways as one-way
2 highways and requiring that all vehicles on them move in one specified direction;
- 3 (5) Regulating the speed and weight of vehicles in public parks;
- 4 (6) Designating any highway as a through highway or designating any
5 intersection as a stop intersection or a yield intersection;
- 6 (7) Restricting the use of highways as provided in Title 24 of this article;
- 7 (8) Regulating the operation of bicycles, requiring them to be registered,
8 and imposing a registration fee;
- 9 (9) Regulating or prohibiting the turning of vehicles or specified types of
10 vehicles at intersections;
- 11 (10) Altering speed limits as provided in Title 21, Subtitle 8 of this article;
- 12 (11) Regulating through truck traffic and prohibiting trucks from using any
13 highway or alley that is not designated or maintained as a part or extension of the State or
14 federal highway system, provided the local authority has designated an adequate alternate
15 route for diverted truck traffic;
- 16 (12) Adopting any other traffic regulations as specifically authorized in the
17 Maryland Vehicle Law;
- 18 (13) Regulating taxi stands, including taxi stands in the middle of a block;
- 19 (14) (i) In this paragraph, "all-terrain vehicle" includes an off-highway
20 motorcycle.
- 21 (ii) 1. Subject to item 2 of this item, except in Allegany County
22 and Garrett County, designating a certain portion of highways upon which snowmobiles
23 may travel for the sole purpose of gaining access to snowmobile trails; but
- 24 2. Designating only those highways which divide snowmobile
25 trails and which would otherwise obstruct direct access between snowmobile trails; and
- 26 (iii) In Allegany County and Garrett County:
- 27 1. Authorizing a person to:
- 28 A. Cross a highway on an all-terrain vehicle or a snowmobile
29 at a right angle at a speed of not more than 25 miles per hour; or

1 B. Operate an all-terrain vehicle or a snowmobile on not
2 more than 5 miles of highway at a speed of not more than 25 miles per hour; and

3 2. Designating a certain portion of highways upon which
4 all-terrain vehicles and snowmobiles may travel at a speed of not more than 25 miles per
5 hour for the sole purpose of gaining access to:

6 A. Trails on which the operation of an all-terrain vehicle or
7 a snowmobile is authorized;

8 B. Fields; or

9 C. Another area where the operation of an all-terrain vehicle
10 or a snowmobile is authorized;

11 (15) Requiring a motorized minibike to be permitted by the local authority,
12 and imposing a permit fee;

13 (16) In Allegany County, designating crossings on county highways where a
14 person operating a golf cart may cross the highway for continued access to any portion of a
15 golf course;

16 (17) Restricting use of a low speed vehicle on a highway;

17 (18) Authorizing an emergency vehicle not subject to registration to operate
18 on a highway while performing an emergency service as defined in § 19-103 of this article;
19 [and]

20 (19) Authorizing a person to cross a highway on an all-terrain vehicle at a
21 right angle to access a farm or to move from one part of a farm to another part of the same
22 farm; AND

23 **(20) IN CHARLES COUNTY:**

24 **(I) REGULATING THE OPERATION OF OFF-HIGHWAY**
25 **RECREATIONAL VEHICLES;**

26 **(II) REQUIRING OFF-HIGHWAY RECREATIONAL VEHICLES TO**
27 **BE REGISTERED BY THE COUNTY AND IMPOSING A REGISTRATION FEE;**

28 **(III) IMPOSING AGE RESTRICTIONS ON THE OPERATION OF**
29 **OFF-HIGHWAY RECREATIONAL VEHICLES; AND**

30 **(IV) AUTHORIZING THE IMPOUNDMENT OF AN OFF-HIGHWAY**
31 **RECREATIONAL VEHICLE THAT IS THE SUBJECT OF AN ALLEGED VIOLATION OF:**
