## A BILL ENTITLED

## Natural Resources - Maryland Heritage Areas Authority - Funding and Grants

- 3 FOR the purpose of authorizing the Maryland Heritage Areas Authority to award grants 4 and loans to certain entities for the management of certified heritage areas under 5 certain circumstances; establishing the maximum funding amount of certain grants 6 made by the Maryland Heritage Areas Authority; decreasing the percentage of 7 Program Open Space funds transferred to the Maryland Heritage Areas Authority 8 Financing Fund that may be used for certain operating expenses; repealing a 9 provision of law authorizing the distribution of certain money to the Maryland 10 Historical Trust; increasing the maximum amount of certain funding available to the 11 State that may be transferred to the Maryland Heritage Areas Authority Financing 12 Fund; and generally relating to the Maryland Heritage Areas Authority.

- 23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 24 That the Laws of Maryland read as follows:
- 25 Article Financial Institutions
- 26 13–1113.

- 1 (a) As provided in the State budget, AND SUBJECT TO SUBSECTION (E) OF THIS 2 **SECTION,** the Authority may award: 3 Grants and loans to local jurisdictions or other appropriate entities for planning, design, acquisition, development, preservation, restoration, interpretation, 4 marketing, [and] programming, AND MANAGEMENT of certified heritage areas; and 5 6 Grants to local jurisdictions or other appropriate entities to develop **(2)** 7 management plans in recognized heritage areas. 8 (b) A grant to develop a management plan may not exceed [50%] 80% of the cost 9 of the management plan. 10 (c) An acquisition or development grant: 11 May not be used for any purpose other than implementation of the (1)12 certified heritage area in conformity with the approved management plan; [and] MAY BE IN AN AMOUNT UP TO \$300,000; AND 13 (2)May not exceed [50%] 80% of the total project cost for which the grant 14 **(3)** 15 is awarded. 16 (d) Subject to paragraph (2) of this subsection, the Authority may make (1)program grants to local jurisdictions and other appropriate entities: 17 18 (i) To develop and present interpretive exhibits, materials or other appropriate products to further the educational and recreational objectives of the certified 19 20heritage areas program; and 21To encourage revitalization of, and reinvestment in, certified (ii) 22heritage area resources. 23 A program grant made by the Authority under paragraph (1) of this (2) 24subsection [may]: 25**(I)** MAY BE IN AN AMOUNT UP TO \$300,000; AND
- 26 (II) MAY not exceed [50%] 80% of the estimated project cost.
- 27 (e) Through the resources of the members of the Authority and in cooperation with other State agencies, the Authority shall provide technical assistance to management 29 entities implementing a management plan.

- 1 (a) There is a Maryland Heritage Areas Authority Financing Fund. 2 (b) (1) The Authority shall use the Fund as a continuing, nonlapsing, revolving 3 fund for carrying out the purposes of this subtitle. 4 No part of the Fund may revert or be credited to the General Fund or to any other special fund of the State. 5 6 The Authority shall place all of the following receipts in the Fund: (c) 7 (1) Proceeds from the sale of bonds; 8 (2) Revenues that the Authority collects or receives from any source under 9 this subtitle; and 10 (3)Any additional revenue, gift, donation, or money received or paid to it 11 from any other source authorized by law. 12 (d) The Authority shall pay all expenses and make all expenditures from the Fund. 13 14 (1)The Authority may pledge and charge all or a portion of the receipts of 15 the Fund for the payment of: 16 (i) Debt service on bonds of the Authority; and 17 All reasonable charges and expenses related to borrowing by the Authority and management of the obligations of the Authority. 18 19 (2)A pledge made under paragraph (1) of this subsection is effective as 20 provided in § 13–1119 of this subtitle and any applicable resolution of the Authority. The State Treasurer shall: 21(f) 22(1) Invest and reinvest the Fund in the same manner as State funds; and 23(2)Transfer any investment earnings to the credit of the Fund. 24In this subsection, "Program Open Space funds transferred to the (g) (1) 25Authority" means the money appropriated to the Fund from Program Open Space funds under § 5–903(a) of the Natural Resources Article. 26
- 27 (2) Except as provided in paragraph (3) of this subsection, Program Open Space funds transferred to the Authority may not be used to pay the operating expenses of the Authority, debt service of bonds issued by the Authority, or administrative expenses related to bonds issued by the Authority.

1 (3)(i) Up to [10%] 7% of Program Open Space funds transferred to the 2 Authority may be used to pay the operating expenses of the Authority. 3 (ii) Up to 50% of Program Open Space funds transferred to the 4 Authority may be expended for debt service on bonds issued by the Authority. 5 For fiscal year 2012 only, an additional \$500,000 of Program 6 Open Space funds transferred to the Authority may be used to pay operating expenses in 7 the Department of Planning. 8 **Article - Natural Resources** 9 5-903. 10 Of the funds distributed to Program Open Space under § 13–209 of the Tax – Property Article, up to \$3,000,000 may be transferred by an appropriation in 11 12 the State budget, or by an amendment to the State budget under Title 7, Subtitle 2 of the State Finance and Procurement Article, to the Maryland Heritage Areas Authority 13 Financing Fund established under Title 13, Subtitle 11 of the Financial Institutions Article 14 15 to be used for the purposes provided in that subtitle. 16 Of the amount transferred under subparagraph (i) of this 17 paragraph, up to \$300,000 may be distributed to the Maryland Historical Trust within the Department of Planning to be awarded as noncapital historic preservation grants. 18 19 (2)(i) Of the remaining funds not appropriated under paragraph 20 [(1)(i)] (1) of this subsection: 21A. One half of the funds shall be used for recreation and open 22space purposes by the Department and the Historic St. Mary's City Commission; and 23 B. 20% of the funds or \$21,000,000, whichever is greater, 24shall be appropriated to the Forest and Park Service in the Department to operate State 25forests and parks. 26 2. Except as otherwise provided in this section, any funds the 27 General Assembly appropriates to the State under this subsection shall be used only for 28land acquisition projects. 29 In addition to the \$3,000,000 under paragraph [(1)(i)] (1) of this (iv) 30 subsection that may be transferred to the Maryland Heritage Areas Authority Financing Fund, up to [\$3,000,000] \$9,000,000 of the State's share of funds available under 31 32 subparagraph (i)1A of this paragraph may be transferred by an appropriation in the State

budget or by an amendment to the State budget under Title 7, Subtitle 2 of the State
