BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article 12 – Garrett County 30.21. (A) Except for transactions under PARAGRAPHS (5) AND (6) OF THIS **DIVISION OR** division (D) of this section, professional services required to be licensed by the State of Maryland, or as otherwise authorized by law, the County Commissioners, or any employee of Garrett County, may not enter into any contract of sale or purchase to

6 7 8	(3) Any contract of sale shall be awarded to the highest responsible bidder, and any contract of purchase shall be awarded to the lowest responsible bidder, but the County Commissioners shall have the right to reject any and all bids.
9 10 11	(4) Any contract entered into in violation of the provisions of this section shall be null and void. The provisions of this section shall not apply to necessary repairs made in case of emergency.
