(b) A cannabis agent registration is valid for 2 years.

19 (d) (1) The Administration may not register as a cannabis agent an individual 20 who does not meet the criteria established under subsection (c) of this section.

21 (2) The Administration may disqualify an individual from registering as a 22 cannabis agent if the individual has been convicted of or pleaded nolo contendere to a crime 23 involving moral turpitude, whether or not any appeal or other proceeding is pending to 24 have the conviction or plea set aside.

25 (e) The Administration may not deny a cannabis agent registration based on any 26 cannabis–related offenses occurring before July 1, 2023.

(f) A cannabis licensee shall require each registered cannabis agent to completean annual responsible vendor training program authorized under this title.

(g) A registration of a cannabis agent issued by the Natalie M. LaPrade Medical
 Cannabis Commission on or before July 1, 2023, shall:

AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2025. 21
