## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Cannabis Agents – Registration – Security Guards**

3 FOR the purpose of providing that a cannabis agent who is employed to provide security  
4 services for a cannabis licensee or cannabis registrant as a security guard or by a  
5 security guard agency is not required to obtain a State or national criminal history  
6 records check if the cannabis agent is authorized to provide security guard services  
7 in accordance with certain provisions of law; and generally relating to cannabis agent  
8 registration and security guards.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
20 That the Laws of Maryland read as follows:

21 **Article – Alcoholic Beverages and Cannabis**

2 (a) A cannabis agent must be registered with the Administration before the agent  
3 may volunteer or work for a cannabis licensee or cannabis registrant.

4 (b) A cannabis agent registration is valid for 2 years.

5 (c) **(1) [To] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**  
6 **SUBSECTION, TO** register as a cannabis agent with the Administration, an individual  
7 must:

8 [(1)] **(I)** be at least 21 years old; and

9 [(2)] **(II)** if the records are legally accessible, obtain a State and national  
10 criminal history records check in accordance with § 36–505 of this subtitle.

11 **(2) A CANNABIS AGENT WHO IS EMPLOYED TO PROVIDE SECURITY**  
12 **SERVICES FOR A CANNABIS LICENSEE OR CANNABIS REGISTRANT AS A SECURITY**  
13 **GUARD OR BY A SECURITY GUARD AGENCY, AS DEFINED IN § 19–101 OF THE**  
14 **BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE, IS NOT REQUIRED TO**  
15 **OBTAIN A STATE OR NATIONAL CRIMINAL HISTORY RECORDS CHECK IN**  
16 **ACCORDANCE WITH § 36–505 OF THIS SUBTITLE IF THE CANNABIS AGENT IS**  
17 **AUTHORIZED TO PROVIDE SECURITY GUARD SERVICES UNDER TITLE 19, SUBTITLE**  
18 **4 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.**

19 (d) (1) The Administration may not register as a cannabis agent an individual  
20 who does not meet the criteria established under subsection (c) of this section.

21 (2) The Administration may disqualify an individual from registering as a  
22 cannabis agent if the individual has been convicted of or pleaded nolo contendere to a crime  
23 involving moral turpitude, whether or not any appeal or other proceeding is pending to  
24 have the conviction or plea set aside.

25 (e) The Administration may not deny a cannabis agent registration based on any  
26 cannabis–related offenses occurring before July 1, 2023.

27 (f) A cannabis licensee shall require each registered cannabis agent to complete  
28 an annual responsible vendor training program authorized under this title.

29 (g) A registration of a cannabis agent issued by the Natalie M. LaPrade Medical  
30 Cannabis Commission on or before July 1, 2023, shall:

31 (1) be valid under this title; and

1 (2) authorize the cannabis agent to be employed by or volunteer with a  
2 licensed cannabis business.

3 **Article – Business Occupations and Professions**

4 19–101.

5 (a) In this title the following words have the meanings indicated.

6 (k) “Security guard” means an individual who, regardless of whether the  
7 individual is described as a security guard, watchman, or private patrolman or by other  
8 title:

9 (1) (i) is an employee of a security guard agency; and

10 (ii) provides security guard services to another person on behalf of  
11 the security guard agency; or

12 (2) (i) is an employee of a security guard employer; and

13 (ii) provides security guard services to the security guard employer.

14 (l) (1) “Security guard agency” means a person who conducts a business that  
15 provides security guard services.

16 (2) “Security guard agency” does not include:

17 (i) a person that is primarily engaged in the business of owning,  
18 maintaining, or otherwise managing property; or

19 (ii) a security guard employer.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
21 October 1, 2025.
