A BILL ENTITLED

1 AN ACT concerning

2 **Consumer Protection – Solicitation Following a Disaster – Prohibition**

3 FOR the purpose of prohibiting a contractor or person acting on behalf of a contractor from
4 soliciting or attempting to solicit a disaster victim within a certain period of time
5 after a disaster; establishing that a violation of this Act is an unfair, abusive, or
6 deceptive trade practice; and generally relating to solicitation following a disaster.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Commercial Law**

25 13–301.

1 Unfair, abusive, or deceptive trade practices include any:

2 (14) Violation of a provision of:

3 (xlii) Section 12–6C–09.1 of the Health Occupations Article; [or]

4 (xliii) Title 14, Subtitle 48 of this article; or

5 **(XLIV) SECTION 14–1328 OF THIS ARTICLE; OR**

6 **14–1328.**

7 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
8 **INDICATED.**

9 **(2) “CONTRACTOR” MEANS A PERSON, OTHER THAN AN EMPLOYEE**
10 **OF AN OWNER, WHO PERFORMS OR OFFERS OR AGREES TO PERFORM ANY OF THE**
11 **FOLLOWING FOR AN OWNER:**

12 **(I) THE ADDITION TO OR ALTERATION, CONVERSION,**
13 **IMPROVEMENT, MODERNIZATION, REMODELING, REPAIR, OR REPLACEMENT OF A**
14 **BUILDING OR PART OF A BUILDING, OTHER THAN NEW CONSTRUCTION, THAT IS**
15 **USED OR DESIGNED TO BE USED AS A RESIDENCE OR A STRUCTURE ADJACENT TO**
16 **THAT BUILDING;**

17 **(II) AN IMPROVEMENT TO LAND ADJACENT TO THE RESIDENCE;**

18 **(III) CONSTRUCTION, IMPROVEMENT, OR REPLACEMENT, ON**
19 **LAND ADJACENT TO THE RESIDENCE, OF A DRIVEWAY, FALL–OUT SHELTER, FENCE,**
20 **GARAGE, LANDSCAPING, DECK, PIER, PORCH, OR SWIMMING POOL;**

21 **(IV) A SHORE EROSION CONTROL PROJECT, AS DEFINED UNDER**
22 **§ 8–1001 OF THE NATURAL RESOURCES ARTICLE, FOR A RESIDENTIAL PROPERTY;**

23 **(V) CONNECTION, INSTALLATION, OR REPLACEMENT IN THE**
24 **RESIDENCE OF A DISHWASHER, DISPOSAL, OR REFRIGERATOR WITH AN ICEMAKER**
25 **TO EXISTING EXPOSED HOUSEHOLD PLUMBING LINES;**

26 **(VI) INSTALLATION IN THE RESIDENCE OF AN AWNING, FIRE**
27 **ALARM, OR STORM WINDOW; OR**

28 **(VII) WORK DONE ON INDIVIDUAL CONDOMINIUM UNITS.**

1 **(3) (I) “DISASTER” MEANS A SERIOUS EVENT THAT CAUSES HARM**
2 **TO A HOME, BUILDING, OR OTHER STRUCTURE.**

3 **(II) “DISASTER” INCLUDES A FIRE, FLOOD, HURRICANE, OR**
4 **OTHER NATURAL EVENT THAT CAUSES HARM.**

5 **(B) THIS SECTION DOES NOT APPLY TO A CONTRACTOR, OR A PERSON**
6 **ACTING ON BEHALF OF A CONTRACTOR, WHO IS ENGAGED IN AN ONGOING BUSINESS**
7 **RELATIONSHIP, OTHER THAN MERE SOLICITATION, WITH A VICTIM OF A DISASTER**
8 **BEFORE THE DISASTER OCCURS.**

9 **(C) FOR PURPOSES OF THIS SECTION, THE EXISTENCE OF A DISASTER IS**
10 **NOT CONTINGENT ON THE DECLARATION OF A STATE OF EMERGENCY BY THE**
11 **FEDERAL GOVERNMENT OR THE GOVERNOR UNDER § 14-107 OF THE PUBLIC**
12 **SAFETY ARTICLE, OR A LOCAL DISASTER DECLARATION AS DEFINED UNDER §**
13 **14-110.5 OF THE PUBLIC SAFETY ARTICLE.**

14 **(D) A CONTRACTOR, OR A PERSON ACTING ON BEHALF OF A CONTRACTOR,**
15 **MAY NOT SOLICIT OR ATTEMPT TO SOLICIT A DISASTER VICTIM WITHIN 48 HOURS**
16 **AFTER A DISASTER.**

17 **(E) A VIOLATION OF SUBSECTION (D) OF THIS SECTION IS:**

18 **(1) AN UNFAIR, ABUSIVE, OR DECEPTIVE TRADE PRACTICE, AS**
19 **DEFINED UNDER TITLE 13 OF THIS ARTICLE; AND**

20 **(2) SUBJECT TO THE ENFORCEMENT AND PENALTY PROVISIONS OF**
21 **TITLE 13 OF THIS ARTICLE.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2025.
