A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Driver’s Licenses – Electronic Credentials**
3 **(Maryland Mobile ID Enhancement Act)**

4 FOR the purpose of authorizing the Motor Vehicle Administration to enter into an
5 agreement to facilitate the issuance, use, and verification of electronic credentials
6 through a national association of motor vehicle agencies; authorizing an individual
7 who will operate a rented vehicle to use a certain electronic credential showing a
8 representation of a valid driver’s license, instead of a driver’s license, to rent the
9 vehicle; and generally relating to the use of electronic credentials.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Transportation**

18 16–1002.

19 (a) The Administration may issue an electronic credential to an individual in
20 addition to, and not instead of, a license or an identification card if the Administration has
21 issued to the individual:

22 (1) A license; or

23 (2) An identification card under § 12–301 of this article.

1 (b) The Administration may enter into agreements with an agency of the State,
2 another state, or the United States, **OR THROUGH A NATIONAL ASSOCIATION OF MOTOR**
3 **VEHICLE AGENCIES**, to facilitate the issuance, use, and verification of electronic
4 credentials issued by the Administration or another state.

5 (c) The Administration may create an electronic credential that:

6 (1) Is capable of producing both a full profile and a limited profile; and

7 (2) Satisfies the purpose for which the profile is being presented.

8 (d) The Administration shall design the electronic credential in a manner that
9 allows the credential holder to maintain physical possession of the device on which the
10 electronic credential is accessed during verification.

12 (a) A person may not rent a motor vehicle, trailer, or semitrailer to any other
13 person unless the individual who will operate the rented vehicle:

14 (1) **(I)** Holds a driver's license issued under Title 16 of this article,
15 which license authorizes [him] **THE INDIVIDUAL** to drive or tow, as the case may be,
16 vehicles of the class rented; **OR**

17 **(II) POSSESSES AN ELECTRONIC CREDENTIAL ISSUED UNDER**
18 **TITLE 16, SUBTITLE 10 OF THIS ARTICLE SHOWING A REPRESENTATION OF A VALID**
19 **DRIVER'S LICENSE;**

20 (2) Is a nonresident who:

21 (i) **1.** Has with [him] **THE INDIVIDUAL** a license to drive issued
22 to [him] **THE INDIVIDUAL** by the state or country of [his] **THE INDIVIDUAL'S** residence,
23 which license authorizes [him] **THE INDIVIDUAL** in that state or country to drive or tow,
24 as the case may be, vehicles of the class rented; **OR**

25 **2. POSSESSES AN ELECTRONIC CREDENTIAL ISSUED BY**
26 **THE INDIVIDUAL'S STATE OF RESIDENCE SHOWING A REPRESENTATION OF A VALID**
27 **DRIVER'S LICENSE, IF THE INDIVIDUAL'S STATE OF RESIDENCE HAS ENTERED INTO**
28 **A FACILITATION AGREEMENT WITH THE ADMINISTRATION UNDER § 16–1002(B) OF**
29 **THIS ARTICLE;** and

30 (ii) Is at least the same age as that required of a resident to drive or
31 tow, as the case may be, the vehicle rented; or

1 (3) Otherwise is specifically authorized by Title 16 of this article to drive
2 or tow, as the case may be, vehicles of the class rented.

3 (b) (1) A person may not rent a motor vehicle, trailer, or semitrailer to any
4 other person unless the lessor or his agent:

5 (i) Has inspected the license to drive **OR ELECTRONIC**
6 **CREDENTIAL** of the individual who will operate the rented vehicle;

7 (ii) Has compared and verified:

8 1. The signature on the license **OR ELECTRONIC**
9 **CREDENTIAL** with the signature of the individual, as written in the presence of the lessor
10 or agent; and

11 2. The physical description on the license **OR ELECTRONIC**
12 **CREDENTIAL** with the physical appearance of the individual; and

13 (iii) Has verified that the license is not expired.

14 (2) An inspection of a license **OR AN ELECTRONIC CREDENTIAL** under
15 this section may be through electronic or digital means.

16 **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act may not be construed
17 to affect the ability of the Motor Vehicle Administration to authorize and implement the
18 use of electronic credentials in matters other than rental vehicle transactions.

19 **SECTION 3. AND BE IT FURTHER ENACTED,** That this Act shall take effect
20 October 1, 2025.
