AN ACT concerning
<u>Civil Actions –</u> Child Sexual Abuse Claims Against the State – Time Limitation
FOR the purpose of prohibiting certain actions under the Child Victims Act against the State or a unit of State government from being filed on or after a certain date altering certain provisions relating to the award of noneconomic damages to a claimant in an action for child sexual abuse; altering certain provisions relating to the liability of the State under the Maryland Tort Claims Act and of a local government under the Local Government Tort Claims Act for certain claims of child sexual abuse; altering certain provisions relating to the defense of sovereign immunity by a county board of education to certain claims of child sexual abuse; altering certain provisions relating to minimum liability insurance coverage requirements for county boards of education; and generally relating to civil actions for child sexual abuse.
