Education – Artificial Intelligence – Guidelines, Professional Development, and Task Force and Professional Development

FOR the purpose of requiring the State Department of Education, in consultation with the State Board of Education, and the Task Force on Artificial Intelligence in K-12 Education relevant stakeholders, to develop or and periodically update certain guidance and strategies on artificial intelligence for county boards of education; requiring the State Department of Education, in consultation with the Department of Information Technology, to develop and update annually a list of approved artificial intelligence tools; requiring each county board to designate an employee to facilitate the use of artificial intelligence in the local school system and to conduct an annual inventory of systems that employ artificial intelligence; requiring the Career and Technical Education Committee to ensure that artificial intelligence literacy is a component of workforce preparation; requiring the State Department of Education, in consultation with certain entities, to develop and administer a certain artificial intelligence needs assessment; requiring the State Department of Education to promote training and workforce development in artificial intelligence; establishing the Task Force on Artificial Intelligence in K-12 Education; requiring the Career and Technical Education Committee and the CTE Skills Standards Advisory Committee to use the Department's guidance and, if necessary, consult with the Department before incorporating the use of artificial intelligence into certain CTE-based actions; and generally relating to artificial intelligence in primary and secondary education.
