18 19	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

22	(a) In this subtitle the following words have the meanings indicated.
23 24	(d) (1) "Rehabilitation practitioner" means an individual who provides vocational rehabilitation services.



(2) 1 "Rehabilitation practitioner" includes: 2 (i) a nurse certified by the State Board of Nursing as a nurse case 3 manager; a rehabilitation counselor; [and] 4 (ii) 5 (iii) a vocational evaluator; AND 6 (IV) A LICENSED CERTIFIED SOCIAL WORKER-CLINICAL. 7 9-6A-04. 8 This subtitle does not limit the right of any individual to engage in a health (a) 9 occupation that the individual otherwise is authorized to engage in under the Health 10 Occupations Article. 11 (b) The Commission has the authority to adopt and enforce rules and regulations 12 regarding the standards of practice of rehabilitation counselors and vocational evaluators. 13 (c) Violation of the rules and regulations adopted or enforced by the Commission, 14 THE STATE BOARD OF SOCIAL WORK EXAMINERS, or the State Board of Nursing in 15 accordance with this title by a rehabilitation practitioner shall be grounds for denial of a 16 registration to any applicant, or suspension or revocation of a registrant's registration 17 pursuant to §§ 9–6A–15 and 9–6A–16 of this subtitle. 9-6A-09. 18 19 **(1)** THIS SUBSECTION DOES NOT APPLY TO A LICENSED CERTIFIED (d) 20 SOCIAL WORKER-CLINICAL. 21**(2)** In addition to the requirements of subsections (b) and (c) of this section: 22 a rehabilitation counselor who has met the education [(1)] (I) 23requirements under subsection (b)(1) or (2) of this section to qualify for registration shall 24work under the administrative supervision of a certified rehabilitation counselor, certified 25vocational evaluator, certified disability management specialist, certified case manager, or 26 certified rehabilitation registered nurse; and 27 [(2)] (II) a vocational evaluator who has met the education requirements 28under subsection (c)(1) or (2) of this section shall work under the administrative supervision 29 of a certified vocational evaluator, certified rehabilitation counselor, certified disability 30 management specialist, certified case manager, or certified rehabilitation registered nurse.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2025.
