A BILL ENTITLED

1 AN ACT concerning

2 **Business Regulation – Retail Stores – Carryout Bags**

3 FOR the purpose of prohibiting a county or municipal corporation from requiring a retail
4 establishment to impose a fee, tax, or charge for a carryout bag, except under certain
5 circumstances; requiring that certain customers be exempted from any fee, tax, or
6 charge for a carryout bag; and generally relating to fees for carryout bags from retail
7 stores.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Business Regulation**

16 **19–108.**

17 (A) (1) IN THIS SECTION THE FOLLOWING TERMS HAVE THE MEANINGS
18 INDICATED.

19 (2) “LOCAL JURISDICTION” MEANS A COUNTY OR MUNICIPAL
20 CORPORATION.

21 (3) (I) “PUBLIC ASSISTANCE PROGRAM” MEANS ANY
22 PUBLICLY FUNDED BENEFIT PROGRAM THAT A RECIPIENT CAN USE TO PURCHASE
23 FOOD.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (II) "PUBLIC ASSISTANCE PROGRAM" INCLUDES:

2 1. THE FEDERAL SUPPLEMENTAL NUTRITION
3 ASSISTANCE PROGRAM (SNAP);

4 2. THE STATE FAMILY INVESTMENT PROGRAM (FIP);

5 3. THE FEDERAL WOMEN, INFANTS, AND CHILDREN
6 PROGRAM (WIC); AND

7 4. ANY OTHER PROGRAM THAT PROVIDES PUBLICLY
8 FUNDED ASSISTANCE THAT CAN BE USED TO PURCHASE FOOD.

9 (B) (1) NOTWITHSTANDING ANY OTHER LAW, A LOCAL JURISDICTION
10 MAY NOT ADOPT OR ENFORCE A LAW OR AN ORDINANCE THAT REQUIRES A RETAIL
11 ESTABLISHMENT TO CHARGE AND COLLECT A FEE, A TAX, OR ANY OTHER CHARGE
12 FOR THE USE OF A CARRYOUT BAG AT THE POINT OF SALE UNLESS THE LAW OR
13 ORDINANCE:

14 (I) WAS IN EFFECT BEFORE JANUARY 1, 2025; AND

15 (II) REQUIRES THAT REVENUE GENERATED FROM THE SALE OF
16 CARRYOUT BAGS BE PAID TO THE LOCAL JURISDICTION TO BE USED ONLY FOR
17 ENVIRONMENTAL SUPPORT PURPOSES.

18 (2) A LOCAL JURISDICTION AUTHORIZED UNDER THIS SECTION TO
19 REQUIRE RETAIL ESTABLISHMENTS TO CHARGE AND COLLECT A FEE, A TAX, OR ANY
20 OTHER CHARGE FOR THE USE OF A CARRYOUT BAG AT THE POINT OF SALE SHALL
21 REQUIRE RETAIL ESTABLISHMENTS TO EXEMPT FROM THE CHARGE ANY CUSTOMER:

22 (I) USING FUNDS FROM A PUBLIC ASSISTANCE PROGRAM TO
23 PAY FOR ALL OR PART OF THEIR PURCHASE; OR

24 (II) WHO IS AT LEAST 65 YEARS OLD.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2025.
