14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND That the Laws of Maryland read as follows:

18 19 20	(a) In addition to any organization and capitalization fee required under $\S 1-204$ of this subtitle, subject to subsection (c) of this section, the Department shall collect the fees specified in subsection (b) of this section.



22 23 24	(13) Beginning in fiscal year 2022, the Department shall waive the filing fee for a business entity described under paragraph (3)(ii) of this subsection for each year that the entity provides evidence to the Department that:
25 26	(i) The entity is required to comply with and is in compliance with Title 12 of the Labor and Employment Article; or
27 28 29	(ii) The entity otherwise provides an employer–offered savings arrangement, as defined in $\S$ 12–101(e) of the Labor and Employment Article, that is in compliance with federal law.
30 31	(14) There is no processing fee for documents filed to dissolve, cancel, or terminate an entity under this subsection.

(c) For each fee identified under subsection (b) of this section as nonrefundable, the Department shall adopt regulations to specify the conditions under which the fee shall be nonrefundable and the conditions under which the fee may be applied to a resubmission of a document for filing, recording, or processing.



SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 October 1, 2025.
