## A BILL ENTITLED

1 AN ACT concerning

2 **Youth Services Bureaus – Criminal History Records Checks – Employees,**  
3 **Volunteers, and Interns**

4 FOR the purpose of authorizing youth services bureaus to request a criminal history  
5 records check from the Criminal Justice Information System Central Repository for  
6 employees, volunteers, and interns; and generally relating to criminal history  
7 records checks by a youth services bureau.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
25 That Section(s) 9–233(d) and (e) of Article – Human Services of the Annotated Code of  
26 Maryland be renumbered to be Section(s) 9–233(e) and (f), respectively.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
2 as follows:

3 **Article – Human Services**

4 9–233.

5 (a) (1) In this section[, “youth”] **THE FOLLOWING WORDS HAVE THE**  
6 **MEANINGS INDICATED.**

7 (2) **“CRIMINAL REPOSITORY” MEANS THE CRIMINAL JUSTICE**  
8 **INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT OF PUBLIC**  
9 **SAFETY AND CORRECTIONAL SERVICES.**

10 (3) **“YOUTH services bureau” means a community–based entity that is**  
11 **operated:**

12 [(1)] (I) to provide community–oriented delinquency prevention, youth  
13 suicide prevention, drug and alcohol abuse prevention, and youth development;

14 [(2)] (II) to ameliorate conditions that contribute to delinquency, youth  
15 suicide, drug and alcohol abuse, and family disruption; and

16 [(3)] (III) to function as an advocate of youth needs.

17 (D) (1) **A YOUTH SERVICES BUREAU MAY APPLY TO THE CENTRAL**  
18 **REPOSITORY FOR A STATE AND NATIONAL CRIMINAL HISTORY RECORDS CHECK**  
19 **FOR AN EMPLOYEE, A VOLUNTEER, OR AN INTERN OF THE BUREAU.**

20 (2) **AS PART OF THE APPLICATION FOR A CRIMINAL HISTORY**  
21 **RECORDS CHECK, THE BUREAU SHALL SUBMIT TO THE CENTRAL REPOSITORY:**

22 (I) **A COMPLETE SET OF LEGIBLE FINGERPRINTS TAKEN IN A**  
23 **FORMAT APPROVED BY THE DIRECTOR OF THE FEDERAL BUREAU OF**  
24 **INVESTIGATION;**

25 (II) **THE MANDATORY PROCESSING FEE REQUIRED BY THE**  
26 **FEDERAL BUREAU OF INVESTIGATION FOR A FEDERAL CRIMINAL HISTORY**  
27 **RECORDS CHECK; AND**

28 (III) **THE FEE AUTHORIZED UNDER § 10–221(B)(7) OF THE**  
29 **CRIMINAL PROCEDURE ARTICLE FOR ACCESS TO MARYLAND CRIMINAL HISTORY**  
30 **RECORDS.**

1           **(3) IN ACCORDANCE WITH §§ 10–201 THROUGH 10–229 OF THE**  
2 **CRIMINAL PROCEDURE ARTICLE, THE CENTRAL REPOSITORY SHALL FORWARD TO**  
3 **THE BUREAU AND THE INDIVIDUAL THE INDIVIDUAL’S CRIMINAL HISTORY RECORD**  
4 **INFORMATION.**

5           **(4) INFORMATION OBTAINED FROM THE CENTRAL REPOSITORY**  
6 **UNDER THIS SECTION:**

7                   **(I) IS CONFIDENTIAL;**

8                   **(II) MAY NOT BE REDISSEMINATED; AND**

9                   **(III) SHALL BE USED ONLY FOR THE EMPLOYMENT AND**  
10 **VOLUNTEERING PURPOSES AUTHORIZED BY THIS SECTION.**

11           **(5) THE SUBJECT OF A CRIMINAL HISTORY RECORDS CHECK UNDER**  
12 **THIS SECTION MAY CONTEST THE CONTENTS OF THE CRIMINAL HISTORY RECORD**  
13 **INFORMATION ISSUED BY THE CENTRAL REPOSITORY AS PROVIDED IN § 10–223 OF**  
14 **THE CRIMINAL PROCEDURE ARTICLE.**

15           **(6) IF CRIMINAL HISTORY RECORD INFORMATION IS REPORTED TO**  
16 **THE CENTRAL REPOSITORY AFTER THE DATE OF THE INITIAL CRIMINAL HISTORY**  
17 **RECORDS CHECK, THE CENTRAL REPOSITORY SHALL PROVIDE TO THE BUREAU AND**  
18 **THE INDIVIDUAL REVISED CRIMINAL HISTORY RECORD INFORMATION.**

19           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2025.
