1 AN ACT concerning

2 **Local Government – Hiring and Promotion Preferences for Veterans and**
3 **Spouses of Service Members and Veterans**
4 **(Families Serve Act)**

5 FOR the purpose of authorizing counties and municipalities to grant, ~~by local law,~~ a
6 preference in the hiring and promotion to eligible veterans, spouses of eligible service
7 members, spouses of certain eligible veterans and eligible service members, and
8 surviving spouses of deceased eligible veterans; authorizing counties and
9 municipalities to adopt a local law that allows for the application of a certain credit
10 on a selection test for eligible spouses, eligible veterans, spouses of certain eligible
11 veterans, and surviving spouses of deceased eligible veterans; and generally relating
12 to hiring and promotion preferences for veterans and spouses of service members
13 and veterans.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That Section(s) 1–204 through 1–206 of Article – Local Government of the Annotated Code
20 of Maryland be renumbered to be Section(s) 1–205 through 1–207, respectively.

21 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
22 as follows:

23 **Article – Labor and Employment**

24 3–714.

25 (a) (1) In this section the following words have the meanings indicated.

26 (2) “Eligible service member” means a full–time active duty member of any
27 branch of the uniformed services of the United States.

28 (3) “Eligible veteran” means a veteran of any branch of the uniformed
29 services of the United States who has received an honorable discharge or a certificate of
30 satisfactory completion of service, including:

31 (i) the National Guard;

32 (ii) the military reserves;

33 (iii) the Commissioned Corps of the Public Health Service; and

1 (iv) the Commissioned Corps of the National Oceanic and
2 Atmospheric Administration.

3 (4) “EMPLOYER” INCLUDES A COUNTY OR MUNICIPAL CORPORATION.

4 (b) [An] SUBJECT TO SUBSECTION (D) OF THIS SECTION, AN employer may
5 grant a preference in hiring and promotion to:

6 (1) an eligible veteran;

7 (2) the spouse of an eligible veteran who has a service-connected disability;

8 (3) the spouse of an eligible service member; or

9 (4) the surviving spouse of a deceased eligible veteran.

10 (c) Granting a preference under subsection (b) of this section does not violate any
11 State or local equal employment opportunity law.

12 (D) ~~FOR IF AN EMPLOYER WHO THAT IS A COUNTY OR MUNICIPAL~~

20 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
21 INDICATED.

22 (2) “ELIGIBLE SPOUSE” HAS THE MEANING STATED IN § 7-207 OF THE
23 STATE PERSONNEL AND PENSIONS ARTICLE.

24 (3) “ELIGIBLE VETERAN” HAS THE MEANING STATED IN § 7-207 OF
25 THE STATE PERSONNEL AND PENSIONS ARTICLE.

26 (B) (1) IF A COUNTY OR MUNICIPALITY USES A SELECTION TEST FOR THE
27 HIRING OR APPOINTMENT OF EMPLOYEES, THE COUNTY OR MUNICIPALITY MAY
28 ADOPT A LOCAL LAW THAT ALLOWS FOR THE APPLICATION OF A CREDIT OF 10
29 POINTS, OR ITS EQUIVALENT, ON A SELECTION TEST FOR:

30 (I) AN ELIGIBLE SPOUSE;

1 (II) AN ELIGIBLE VETERAN;

2 (III) THE SPOUSE OF AN ELIGIBLE VETERAN WHO HAS A
3 SERVICE-CONNECTED DISABILITY; OR

4 (IV) THE SURVIVING SPOUSE OF A DECEASED ELIGIBLE
5 VETERAN.

6 (2) A LOCAL LAW ADOPTED UNDER PARAGRAPH (1) OF THIS
7 SUBSECTION:

8 (I) MAY ALLOW FOR THE APPLICATION OF A CREDIT OF TWO
9 ADDITIONAL POINTS, OR ITS EQUIVALENT, ON ANY SELECTION TEST FOR A FORMER
10 PRISONER OF WAR; AND

11 (II) IF NECESSARY, SHALL CLARIFY THE APPLICATION OF ANY
12 SPECIAL CREDIT APPLIED UNDER § 1-205 OF THIS SUBTITLE.

13 (C) THE FOLLOWING APPLICANTS ARE INELIGIBLE FOR A CREDIT UNDER
14 THIS SUBSECTION:

15 (1) A CURRENT EMPLOYEE OF A COUNTY OR MUNICIPALITY; AND

16 (2) AN ELIGIBLE VETERAN WHO IS CONVICTED OF A CRIME AFTER
17 BEING DISCHARGED FROM OR COMPLETING MILITARY SERVICE.

19 (a) Frederick County may:

20 (2) require a county employee, as a condition of employment, to elect to
21 receive the payment of wages by debit card or, subject to [§ 1-205(b)] § 1-206(B) and (c) of
22 this article, by direct deposit.

25 (c) (1) (i) In this subsection the following words have the meanings
26 indicated.

27 (ii) “Eligible spouse” means an individual who is married to a
28 full-time active duty member of any branch of the uniformed services of the United States.

1 (iii) "Eligible veteran" means a veteran of any branch of the
2 uniformed services of the United States who has received an honorable discharge or a
3 certificate of satisfactory completion of service, including the National Guard and the
4 military reserves.

5 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
6 October 1, 2025.
