- 23 (6) \$250,000 to support cybersecurity education at the kindergarten, elementary school, and secondary school levels, including at summer camps;
- 25 (7) \$250,000 for a marketing campaign, in consultation with the 26 Department of Commerce, to attract cyber talent and industry to the State; and
- 27 (8) \$250,000 for the Maryland Statewide Computing Alignment to 28 Locate your Education (SCALE) portal.
