2 **Cyber Maryland Program – Revisions**

3 FOR the purpose of transferring the Cyber Maryland Program from the Maryland
4 Technology Development Corporation to the Maryland Department of Labor;
5 altering the duties of the Program; requiring the Program to award certain
6 competitive grants and contracts; altering the purposes for which the Cyber
7 Maryland Fund may be used; altering certain funding requirements related to the
8 Program; ~~requiring that unused balances from certain programs and funds be~~
9 ~~transferred to the Program at the close of the fiscal year;~~ altering the membership of
10 the Cyber Maryland Board; and generally relating to the Cyber Maryland Program.

8 That Section(s) 10–491 and the part “Part XI. Miscellaneous” of Article – Economic
9 Development of the Annotated Code of Maryland be transferred to be Section(s) 11–1701
10 and the subtitle “Subtitle 17. Miscellaneous” of Article – Labor and Employment of the
11 Annotated Code of Maryland.

23 [(b)] (A) There is a Cyber Maryland Program in the [Corporation]
24 DEPARTMENT.

25 [(c)] (B) The purposes of the Program are to:

26 (1) create and execute a talent pipeline that materially reduces workforce
27 vacancies by July 1, 2026;

28 (2) serve as a one–stop shop for employers seeking to leverage cyber
29 workforce development programs offered by the State and its partners;

30 (3) inform cybersecurity training and education programs operated by
31 public or private entities with industry–driven needs;

1 (4) build the most advanced local and State information technology
2 workforce in the nation, which, to the maximum extent possible, reflects the racial, gender,
3 ethnic, and geographic diversity of the State;

4 (5) coordinate and accelerate cybersecurity research and innovation in the
5 State; and

6 (6) support the efforts of the Department of Information Technology to
7 improve the State government's cybersecurity posture, including State agencies, local
8 government units, and critical infrastructure.

9 [(d)] (C) The Program shall:

10 (1) conduct ongoing research by collaborating with the Cybersecurity
11 Association [of Maryland], Inc., Cybersecurity Talent Advisory Board to collect and analyze
12 real-time industry data to identify cybersecurity workforce needs as described in the U.S.
13 Chamber of Commerce Talent Pipeline Management Approach;

14 (2) use the results of the research described in item (1) of this subsection
15 to increase the effectiveness of existing State cybersecurity workforce programs for
16 employers in the State;

17 (3) facilitate partnerships for new training and education programs to
18 address the workforce needs identified under item (1) of this subsection;

19 (4) develop a statewide strategic plan for cybersecurity workforce
20 development, using the results of the research described in item (1) of this subsection and
21 with input from the Cybersecurity Association [of Maryland], Inc., Cybersecurity Talent
22 Advisory Board on or before December 1, 2023; [and]

23 (5) DEVELOP, PROMOTE, SUPPORT, AND INVEST IN TALENT
24 IMPROVEMENT STRATEGIES, SUCH AS STRATEGIES THAT LEVERAGE THE U.S.

26 [(5)] (6) ensure that outcomes of the Program are inclusive and, to the
27 maximum extent practicable, reflect the racial, gender, ethnic, and geographic diversity of

2 [(2)] (B) The purposes of the Fund are to:

3 [(i)] (1) achieve the purposes identified under [subsection (c) of
4 this section] § 11-1702(B) OF THIS SUBTITLE; and

5 [(ii)] (2) support innovative approaches to meeting cybersecurity
6 workforce needs.

7 [(3)] (C) The [Corporation] DEPARTMENT shall administer the Fund.

8 [(4) (i)] (D) (1) The Fund is a special, nonlapsing fund that is not
9 subject to § 7-302 of the State Finance and Procurement Article.

10 [(ii)] (2) The State Treasurer shall hold the Fund separately, and
11 the Comptroller shall account for the Fund.

12 [(5)] (E) The Fund consists of:

13 [(i)] (1) money appropriated in the State budget to the Fund; [and

14 (ii)] (2) **MONEY TRANSFERRED TO THE FUND IN ACCORDANCE**
15 **WITH SUBSECTION (M) OF THIS SECTION; AND**

16 (3) any other money from any other source accepted for the benefit of the
17 Fund.

18 [(6)] (F) The Fund may be used only for:

19 [(i)] (1) administrative expenses of the Program, including hiring
20 staff in accordance with the State budget and hiring consultants and other professionals as
21 necessary to implement, maintain, and administer the Program and the Fund; and

22 [(ii)] (2) providing grants to elementary and secondary schools,
23 institutions of higher education, including community colleges, **EMPLOYERS, INCLUDING**
24 **for-profit corporations, [and] nonprofit organizations, REGISTERED APPRENTICESHIP**
25 **SPONSORS, LOCAL WORKFORCE BOARDS, INDUSTRY ASSOCIATIONS, LABOR UNIONS,**
26 **LOCAL GOVERNMENTS, LOCAL OR REGIONAL ECONOMIC DEVELOPMENT ENTITIES,**

2 Fund in the same manner as other State money may be invested.

3 [(ii)] **(2)** Any interest earnings of the Fund shall be credited to the
4 General Fund of the State.

5 [(9)] **(I)** Expenditures from the Fund may be made only in accordance
6 with the State budget.

7 [(10)] **(J) (1)** For fiscal year [2025 and each year thereafter] **2026**, the
8 Governor[:
