# A BILL ENTITLED

## 1 AN ACT concerning

# State Government - State House Trust - Ten Commandments Monument Display Act

- FOR the purpose of requiring a certain Ten Commandments Monument to be placed on the
  grounds of the Maryland State House; requiring the Commission on Artistic Property
  to oversee the care and maintenance of the monument; establishing the Commission
  on the Ten Commandments Monument; and generally relating to a Ten
  Commandments Monument.

  - Preamble

WHEREAS, The Ten Commandments, found in the Bible at Exodus 20:1–17 and Deuteronomy 5:6–21, are an important component of the moral foundation of the laws and legal system of the United States of America and of the State of Maryland; and

18 WHEREAS, The courts of the United States and various states frequently cite the19 Ten Commandments in published decisions; and

20 WHEREAS, In 2005, the U.S. Supreme Court recognized that it is permissible to 21 display the Ten Commandments on government property in Van Orden v. Perry; and

WHEREAS, In 2019, the U.S. Supreme Court further recognized that the Ten Commandments "have historical significance as one of the foundations of our legal system", in American Legion v. American Humanists Association, and the court also ruled that the

displaying of the Ten Commandments on public property may have "multiple purposes"
such as "historical significance" and represents a "common cultural heritage"; and

WHEREAS, Recognizing the historical role of the Ten Commandments accords with our nation's history and faithfully reflects the understanding of the founders of our nation with respect to the necessity of civic morality to a functional self–government; history records that James Madison, the fourth President of the United States, stated that "[w]e have staked the whole future of our new nation...upon the capacity of each of ourselves to govern ourselves according to the moral principles of the Ten Commandments"; and

9 WHEREAS, In order that they may understand and appreciate the basic principles 10 of the American system of government, the people of the United States and the State of 11 Maryland need to identify the Ten Commandments, one of many sources, as influencing 12 the development of what has become modern law; and

WHEREAS, The placing of a monument to the Ten Commandments on the grounds
 of the Maryland State House would help the people of the United States and the State of
 Maryland to know the Ten Commandments as the moral foundation of the law; and

WHEREAS, It is the Legislature's intent to apply the decision set forth by the U.S. Supreme Court in Van Orden v. Perry, to continue the rich tradition and ensure that the citizens of our State may understand and appreciate the foundational documents of our State and national government, and that in the placing of a monument to the Ten Commandments on the grounds of the Maryland State House would help the people of the United States and the State of Maryland to recognize the Ten Commandments as the moral foundation of the law; now, therefore,

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

30 (a) (1) The Commission is the official custodian of all valuable paintings and 31 other objects of decorative art owned by or loaned to the State, except those located in a 32 State room of the Government House. 10 (2) request the assistance of a nonprofit legal organization that specializes 11 in First Amendment cases to prepare and present a legal defense of the monument.

12 (h) The placement of the monument may not be construed to mean that the State 13 favors any particular religion or denomination over others.

14 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July 15 1, 2025. Section 3 of this Act shall remain effective for a period of 3 years and, at the end of 16 June 30, 2028, Section 3 of this Act, with no further action required by the General 17 Assembly, shall be abrogated and of no further force and effect.
