3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
4 That Section(s) 22–218(c)(4) through (13) of Article – Transportation of the Annotated Code  
5 of Maryland be renumbered to be Section(s) 22–218(c)(5) through (14), respectively.

6 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
7 as follows:

8 **Article – Transportation**

9 22–218.

10 (c) (1) A person may not drive or move on any highway any vehicle or  
11 equipment that is equipped with or displays any light or signal device designed to emit an  
12 oscillating, rotating, blinking, or other type of emission of light, unless designated and  
13 authorized by the Administrator as indicated in paragraphs (2) through [(13)] (14) of this  
14 subsection. The provisions of this section do not prohibit the display and use of any lighting  
15 device that may be permitted or required elsewhere in the Maryland Vehicle Law.
