29 30	(I) IF A DEFENDANT DOES NOT ATTEND THE HEARING, THE DISTRICT COURT SHALL ENTER A DEFAULT JUDGMENT AGAINST THE DEFENDANT.

24 25 26	If the judgment of the circuit court shall be in favor of the person claiming possession, a warrant shall be issued by the court to the sheriff, who shall proceed immediately to execute the warrant.
